**INSPECTION CHECK**
**Taxicab (Vehicle):**

The following items must be checked by the inspector and if there are deficiencies the Owner has **TEN DAYS** from the date of application to correct the defects. License WILL NOT be issued until deficiencies are corrected. Failure to do so can result in refusal of the application.

**Note:** The Inspector is to ensure the large decal with expiration date affixed is placed on the rear bumper of taxicab prior to departure from City Hall.

**Note:** The Owner of a taxi cab is **NOT** required to possess a class 04 license to own a taxi cab but owner/holder shall be advised they may not operate a taxi for hire.

**Note: Initial Taxicab License Only** – The holder will be provided with an information package.
