17-04-166 Lifesaving Society – Kean Award

Council was advised that the City has been awarded the Kean Award by the Lifesaving Society. The Kean Award is presented annually to an affiliate operating a year-round facility in a community of 10,000 to 30,000 people with the largest lifesaving program. The award was accepted by the City's Aquatics Supervisor at the Society's annual meeting on April 8, 2017.

17-04-169 Neighborhood Signs

For the information of the public, two neighborhood signs will be installed for Pearlgate East and Pearlgate Terrace. The signs will be in the same format that has been used on neighborhood signage from previous years to maintain consistency.

17-04-170 Spring 'Curbside Giveaway' – Zone 4 Admiralty Wood Neighborhood

For the information of the public, a curbside giveaway is scheduled for May 13, 2017 at Zone 4 – Admiralty Wood Neighborhood. A brochure outlining the program will be distributed later this month to residents of the area. It was recognized that the inclement weather may have impacted the success of the previously held event (fall of 2016). It was proposed that consideration be given to postponing the event if the weather wasn't conducive, however, it was noted that this would be difficult to do. It was suggested that messaging include not placing items to the curb that would deteriorate in wet weather. The success of the program in other municipalities was acknowledged.

PLANNING AND DEVELOPMENT COMMITTEE

17-04-171 Proposed Mount Pearl Municipal Plan and Development Regulations Amendment C.E.I. Corporation Ltd. – Re-designation and Rezoning 161 Park Avenue

RESOLVED THAT based on the feedback received from area residents and the high level of concerns expressed, and based on the merits of the site specific proposal which prompted the amendment request, the request for the proposed Municipal Plan Re-designation and Development Regulations Amendment for 161 Park Avenue be refused.

<u>Discussion:</u> It was acknowledged that although the proposed development requiring the amendment would not move forward, the property will eventually be developed.

17-04-172 <u>Matter of Accessory Building Removal</u> 44 Roosevelt Avenue

RESOLVED THAT approval be granted to issue an order to the property owner of 44 Roosevelt Avenue to have the accessory building removed by Monday, May 15, 2017.

<u>Discussion:</u> It was confirmed that a complaint had been received and, in addition, the owner had agreed to remove the shed. It was also noted that the location of the shed is very close to the abutting property.
