13-04-222 Public Works Division (Update)

It was noted that the layoff for seasonal operators took place on March 28. Appreciation was extended to the crew for their efforts during the winter season. Seasonal recalls for the summer will take place around the end of April or early May (weather depending). When a full complement of staff has returned to work repairs to damages caused to residential properties as a result of our snow clearing efforts will commence. The sidewalk and street sweepers will be utilized as weather permits and repairs to curbs and sidewalks will also be in full force. Residents are encouraged to report any potholes to the City so repairs can be undertaken in a timely manner.

It was noted that the implementation of the garbage cart system has addressed the issue of household garbage being torn open. It was acknowledged that programs such as the 20 Minute Makeover will address the litter that has accumulated over the winter months around the city.

Amendment – Mount Pearl Development Regulations 2010

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will:

Amend Map 1 - Land Use Zoning Map, as follows:

Rezone the property situated at 912-924 Topsail Road from Commercial General (CG) to Commercial Mix (CM) Use Zone.

The intention of this proposed amendment is to provide Council with the authority to consider a proposed automobile dealership at this location.

13-04-236 Notice of Motion

Amendment – Mount Pearl Development Regulations 2010

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will:

In Section 11- Use Zone Schedules, amend the City Centre (CC) and Commercial-General (CG) use zones by adding the following condition:

Notwithstanding Section 8.20.2 of these Regulations, a Changeable Message Sign may be permitted at the discretion of Council provided that the sign application is processed pursuant to Regulation 4.17 of these Regulations.

The purpose of this proposed amendment is to provide Council with the authority to consider Changeable Message Signs within the CC and CG use zones.

13-04-237 Notice of Motion

Amendment – Mount Pearl Development Regulations 2010

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will:

In Section 6- General Development Standards, amend Subsection 6.26, Non-Conforming Use, by adding the following:

In subclause 6.26.2, in the first paragraph, after the words ".... or altered structurally" and before "unless such building" add the phrase "or relocated on the lot"; and,

In subclause 6.26.2, immediately after clause (e), add the following clause and retitle the current clause (f) to (g):

(f) where the non-conformance is with respect to the standards included in these Regulations, the building, structure, or development shall not be relocated if the relocation would increase the non-conformity; and,

The purpose of this proposed amendment is to provide Council with the discretionary authority to consider the relocation of accessory buildings that are non-conforming with the Regulations

<u>Amendment – Mount Pearl Development Regulations 2010</u>

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will amend the Land Use Zoning Map as follows:

1. Rezone a portion of the property at 79 - 115 Mount Carson Avenue from Commercial – Local (CL) to Commercial – General (CG).

The purpose of this proposed amendment is to provide Council with the authority to permit a four (4) storey mixed use building (with underground garage) consisting of combined residential and commercial uses on the first level, and residential condos on the above three (3) levels on a portion of the property at 79 - 115 Mount Carson Avenue.

Mayor Simms commented on the changes to the Municipal Operating Grants recently announced in the provincial budget. He reassured residents that these changes would not result in changes to the 2013 mil rate. He noted that discussions will now commence regarding a new fiscal arrangement between Government and the City.
