Now Online at City's New Website - www.mountpearl.ca

Council was advised that the Geographic Information System (GIS) as part of the City's new website, at www.mountpearl.ca, is now available to the public. GIS is a new service to distribute spatial and property related information to residents, businesses and visitors to the City of Mount Pearl. The information and data is more up to date than with static maps. This system identifies all properties, buildings, civic numbering, street

information address searches, zoning and natural features of the City. Air photos from 1951, 1994, 2003 and 2006 are also available on line. Connection is also available to Google Street View directly from the map. In future, further features and GIS applications will be added to the site. 10-04-300 Satellite Ambulance Station

RESOLVED THAT an application for the construction of an approximately 215 m² Eastern Health satellite ambulance station and associated site development at 933 Topsail Road be approved and a conditional development permit be issued subject to the conditions outlined in the staff report of April 15, 2010.

<u>Discussion:</u> Council was advised that the Regional Fire Department will be phasing out the provision of ambulance transport services. The Department will respond to 911 calls and provide back-up response to Eastern Health. It was indicated that this service will be a great asset to the City of Mount Pearl and its residents.

10-04-301 Notice of Motion

Amendment – Mount Pearl Development Regulations 1988

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will amend Part II, General Development Standards as follows:

In Regulation 49, titled "Offstreet Parking Requirements" add the following clause:

6. Where an off-street parking space or spaces has/have been approved by the Authority on a lot or property, parking of vehicles shall be on the hard surfaced area of the lot approved for the off-street parking space or spaces and the parking of vehicles shall not be permitted on the landscaped yards of the lot or property.

The intention of this amendment is to provide Council with the authority to prohibit parking on the landscaped yards of lots and properties.

10-04-302 Notice of Motion

<u> Amendment – Mount Pearl Development Regulations 1988</u>

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will

1. Amend Part II – General Development Standards by adding the following immediately after Regulation 53 titled "Parks and Playgrounds and Conservation Uses":

Residential Interior Corner Lots

Where a residential corner lot abuts upon two parts of the same street and is situated within a crescent street or cul de sac, the Authority may use its discretion to permit an accessory building or an attached garage to encroach upon the Flanking Street Side Yard provided that:

- a) the encroachment is on that portion of the lot that is designated as the flanking street side yard and not the front yard of the lot;
- b) the setback of the accessory building or attached garage ensures sufficient distance to accommodate a parking space off the Authority's road right of way:
- the location of the accessory building or garage does not create a visual obstruction to sight lines or hinders the Authority's snow clearing operations; and,
- d) such a decision is made pursuant to Regulation 10 of the Development Regulations.

Renumber the regulations in Part II in a sequential order starting with Regulation 52.

The intention of this amendment is to provide Council with the discretionary authority to permit residential accessory buildings or attached garages on interior cornet lots that will not meet the normal flanking street side yards development standards of the use zones.

10-04-303 Notice of Motion

<u>Amendment – Mount Pearl Development Regulations 1988</u>

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an

amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will:

Rezone the property located at 5 Centennial Street from Commercial-General (GC) to Mixed-Development (MD).

The intention of this amendment is to allow the expansion of the main building at 5 Centennial Street (Wilkin's Automotive Repairs).

10-04-304 Development Permits

Motion - Deputy Mayor Locke/Councillor Aker

RESOLVED THAT development permits issued for the period of April 2 – 16, 2010 be approved as presented.

Question called. Motion carried unanimously.

10-04-305 Building Permits

Motion - Deputy Mayor Locke/Councillor Aker

RESOLVED THAT building permits issued for the period of April 2 - 16, 2010, showing a total construction value of \$9,651,000.00, be approved as presented.

NEW BUSINESS

10-04-306 <u>Composting</u>

Multi-Materials Stewardship Board (MMSB)

Councillor Lane advised of complaints regarding composting in that the proper containers are not being used and this has resulted in attracting rodents to the areas in question. He questioned the status of previous discussions between MMSB and the City's Infrastructure & Public Works Department on this matter. He was of the understanding that a brochure was to be forwarded to residents outlining proper composting methods. He requested that the matter be referred to the Infrastructure & Public Works Committee for consideration and subsequent report.

10-04-307 Branscombes Pond

Councillor Lane advised that residents continue to express concern regarding silting into Branscombes Pond. It was noted that City staff as well as Department of Fisheries & Aquaculture staff have been monitoring the area. They have advised that the water has been tested with good results and a meeting has been held with the developer. It was requested that the matter be referred to the Infrastructure & Public Works Department for a further update and subsequent communication to the (area) residents.

10-04-308 Policy – Green Initiatives – Equipment

Councillor Lane acknowledged receipt of information from the Director of Infrastructure & Public Works regarding the City's current practice of keeping green initiatives in mind when purchasing equipment. He suggested that this practice be formalized into a policy and referred to Council for consideration via the Infrastructure & Public Works Committee.

10-04-309 Beautification – Park Avenue/Pinebud Park

Councillor Lane requested that consideration also be given to improving Pinebud Park when reviewing areas to be beautified in the Park Avenue neighborhood.

10-04-310 <u>Bulk Garbage – Walkway System</u>

Deputy Mayor Locke advised of an area on the walkway system whereby a resident had placed the concrete base/fence post. It was requested that staff investigate the matter and pursue it with the property owner. He reminded residents to take pride in their community, noting that the trail way isn't a dumping ground.

10-04-311 Citizen of the Year

Members of Council extended personal expressions of congratulations to Mr. Bartlett and the Citizen of the Year nominees as well as to the City's co-host – the Kinsmen Club.

10-04-312 Director of Corporate Services

"Mike Badham Award for Outstanding International Volunteer Contribution"

Members of Council extended personal expressions of congratulations to Ms. Peach upon receiving the Mike Badham Award.

10-04-313 <u>Atlantic Mayors Congress</u>

Councillor Stoyles provided an update coming from the Atlantic Mayors' Congress meetings, particular reference was made to the new federal regulations that will require upgrades to municipal wastewater systems. The Congress is requesting a national three-way cost-sharing agreement.

Motion - Councillor Stoyles/Councillor Walsh

RESOLVED THAT approval be granted to write the Federal Minister of the Department of Environment (with copies to the City's M.P. and M.H.A.'s) seeking a federal/provincial/municipal cost sharing arrangement for the upgrading of municipal wastewater systems required to meet the new federal regulations.

<u>Discussion:</u> It was pointed out that the cost to the City of Mount Pearl could potentially result in \$10 million capital and an increased operating cost. Council noted that the gas tax money was put in place to address existing deficiencies not to fund new programs. An opinion was also expressed whereby it was thought that the Federal Government should bear the cost and not download to municipalities. It was agreed that a letter outlining Council's concerns would be prepared for review by Council prior to being forwarded to the Minister of Environment.

Question called. Motion carried unanimously.

10-04-314 Northeast Avalon Joint Council (NEAJC)

Councillor Stoyles advised that the NEAJC will be meeting on April 21, 2010 in the Town of Paradise. The Minister of Municipal Affairs, the Honourable Dianne Whalen, will be the guest speaker.

10-04-315 <u>Municipalities Newfoundland & Labrador (MNL)</u> <u>Avalon Regional Meeting</u>

Councillor Stoyles advised of an Avalon Regional Meeting (MNL) scheduled for May 7 in the Town of Bay Roberts. She noted that Senator Fabian Manning has been confirmed as guest speaker and it is hoped that Minister Peter MacKay will also be in attendance.

10-04-316 <u>City of St. John's – Congratulations</u>

Councillor Walsh extended congratulations to the City of St. John's on the successful Juno Awards event and in recognition of the City of St. John's assistance as a sponsor.
