10-04-236 Adoption of Agenda

10-04-237 Adoption of Minutes

RESOLVED THAT the minutes of the public meeting held on March 23, 2010 be adopted as presented

<u>Errors & Omissions:</u> With reference to minute 10-03-193 (tender – diesel powered lawn mower), it was noted that Council also requested that the Public Works Committee review the implementation of a policy that considers green initiatives for all types of equipment.

BUSINESS ARISING

10-04-238 Ramp from Outer Ring Road – Kenmount Road/McNamara Drive

Council was advised that the above noted intersection falls within the jurisdiction of the Town of Paradise. It was requested that the Director of Infrastructure & Public Works seek clarification from the Town as to their plan to improve traffic flow at this intersection.

10-04-239 <u>Household Hazardous Waste (HHW)</u> <u>Eastern Waste Management (EWM)</u>

Council was advised that information is being sought from the City of St. John's with respect to Mount Pearl providing its residents with a local satellite bi-annual HHW service. It was also noted that a letter has been drafted to the Multi-Materials Stewardship Board with respect to the continuance of a subsidy for this service.

10-04-240 Parkinson's Awareness Month

Mayor Simms signed a proclamation declaring April as Parkinson's Awareness Month in the City of Mount Pearl.

10-04-241 Volunteer Week

Mayor Simms signed a proclamation declaring the period of April 18-24, 2010 as "Volunteer Week" in the City of Mount Pearl. Representatives of the Volunteer Week Committee were welcomed. Mr. Jim Burton, Honorary Chairperson, commented on the value of volunteers to the community and extended appreciation to all.

CORRESPONDENCE

10-04-242 <u>Municipalities Newfoundland & Labrador (MNL)</u>

A copy of a letter from MNL to the Honourable Jerome Kennedy, Minister of Health & Community Services, was presented. MNL provided the Minister with a copy of the City's resolution to "ban the cosmetic use of pesticides" in the Province that had been adopted during their Annual General Meeting.

10-04-243 M.H.A. Steve Kent

A letter was presented from Mr. Kent advising that he presented a congratulatory message to the Frosty Festival Committee and the City during a Member Statement (March 23, 2010).

10-04-244 Office of the Minister – Department of Natural Resources

A letter was presented from the Honourable Kathy Dunderdale acknowledging the City's letter regarding the Animal Health & Protection Act. The Minister advised that a new Act will be tabled during the spring session of the House of Assembly.

COMMITTEE REPORTS

PLANNING & LAND USE DEVELOPMENT COMMITTEE

It was noted that Councillor Aker is employed with NLHC and therefore in a conflict on this issue.

10-04-245 Newfoundland and Labrador Housing Corporation (NLHC)
Reconfiguration of Semi-Detached Building
5 Spruce Avenue

Motion - Deputy Mayor Locke/Councillor Tessier

RESOLVED THAT the rezoning application not be supported at this time and the application to remodel one the units on Spruce Avenue be refused as the proposal is not a permitted use in the RMD use zone.

<u>Discussion:</u> Council was advised that NLHC has withdrawn their application.

Members of Council noted that the initial application from NLHC was refused; however, NLHC requested the matter proceed through the public consultation process. Residents were provided the opportunity to present their input, and as a result, Council listened to their concerns and abided by their wishes. It was noted that although Council didn't support this application in this particular location, they acknowledged the mandate of NLHC and will continue to support their initiatives in the City of Mount Pearl. NLHC clients were also encouraged to approach NLHC should they be in need of assistance. Council referenced items raised by the residents with respect to problems associated with the wooded area, condition of units, sidewalks, and the neighborhood playground will be addressed by the applicable City Departments. Residents were assured that the City will make every effort to ensure NLHC carries through on their responsibility to maintain the existing units in the area. Reference was also made to

Council's initiative associated with housing for seniors as well as subsidized housing – noting that the matter is under active review.

Question called. Motion carried unanimously with Councillor Aker abstaining from voting due to a conflict of interest.

10-04-246 Notice of Motion

<u>Amendment – Mount Pearl Development Regulations 1988</u>

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will amend Schedule "E", land use zoning map by rezoning land within the boundaries of the Simcoe Drive Amendment Area from Residential Medium Density (RMD) to Residential Single Unit Detached 3 (RSU-3).

The intention of this amendment is to provide Council with the regulatory framework to consider development proposals for dwellings of a smaller frontage along Simcoe Drive.

Those lands not being re-zoned shall maintain their present zoning.

10-04-247 <u>Mount Carson Terrace – Phase 5A</u> Subdivision Development Agreement

It was noted that this sign is similar to the existing sign with the exception of improved solar capability. <u>Discussion:</u> Council was advised that a financial update on this project will be provided. It was noted that this change order is part of the contingency funding.

NEW BUSINESS

10-04-264 <u>Highway Signage</u>

Councillor Walsh advised of a resident's complaint regarding the lack of directional highway signage. He noted that the issue had been previously

raised and requested staff investigate its status. He also made reference to the dilapidated condition of the property at the top of the Ruth Avenue Overpass (area to the water tower). The Director of Infrastructure & Public Works advised that the Provincial Government has plans to upgrade ramps. Councillor Aker advised that the land is owned by NLHC and it will eventually be developed to access Southlands in addition to a portion of it being zoned "cemetery" use. It was requested that the applicable agency responsible for this property be requested to clean up the area as well as clarifying the timing and plans for any roadwork in this area.

10-04-265 Spring Clean-Up – Open Spaces

Councillor Stoyles commented on the amount of garbage evident in the trails and open space areas. It was noted that as in other years, City crews will be clean up these areas in addition to the clean up organized by the Community Services Department whereby residents, businesses and schools are invited to participate.

10-04-266 Northeast Avalon Joint Council (NEAJC)

Councillor Stoyles advised that the NEAJC will be meeting on April 21 in the Town of Paradise. Minister Dianne Whalen will be the guest speaker.

10-04-267 Intersection – Old Placentia Road/Smallwood Drive

Deputy Mayor Locke raised an issue of sight impairment when vehicles are turning left onto Smallwood Drive from Old Placentia Road. Matter referred to the Director of Infrastructure & Public Works for review.

10-04-268 Pedestrians

Deputy Mayor Locke reminded drivers to be aware of an increased number of pedestrians as a result of the Easter school break.

10-04-269 <u>Centennial Square</u>

Councillor Lane noted that some of the amenities of Centennial Square are requiring maintenance and requested staff to investigate the matter.

10-04-270 Roaming Cats

Councillor Lane reminded residents that in accordance with the Animal Control Regulations, cats are not allowed to roam.

She spoke of a previous suggestion to consult with the store managers regarding suggestions to deal with flyers left in the shopping carts. It was requested that staff pursue the status of this suggestion.
