14-04-228 Tender – Asphalt Crack Sealing TP-14-007

PLANNING AND DEVELOPMENT COMMITTEE

14-04-229 <u>Wastewater Treatment Facility – Pardy's Holdings Ltd.</u> 30 Kyle Avenue

Motion - Councillor Ledwell/Councillor Tessier

RESOLVED THAT the application by Pardy's Holdings Ltd. to place a trailer on site for the purpose of treating waste water at 30 Kyle Avenue be approved and a development permit issued subject to the following conditions:

- 1. St. John's Regional Fire Department conditions;
- 2. Newfoundland Power's conditions;
- 3. City Inspector's conditions;
- 4. City of St. John's conditions;
- 5. Pollution Prevention Divisions Conditions of approval;
- 6. Engineering Services conditions;
- 7. the total hazardous storage volume capacity to be confirmed by Pardy's and forwarded to the City for verification;
- 8. revised engineered stamped site plan to be submitted illustrating:
 - i. proposed parking areas (to be paved and curbed),
 - ii. containment around transfer of water (catchment area details so no accidental waste goes into the sanitary or storm systems),
 - iii. indication that the catch basin that is in close proximity to the transfer area is not connected to the storm system,
 - iv. sampling port to be on private property and close proximity to source.
 - v. existing site services and easements,
 - vi. all parking and loading / off-loading areas to be paved and curbed,
 - vii. site grading,
 - viii. pre-post storm water calculations to be submitted,
 - ix. wastewater sampling port to be installed on the discharge line from the wastewater treatment facility accessible to City compliance staff,
 - x. currently Pardy's are batch processing, and the report sent to the City of Mount Pearl monthly will indicate the proposed volume of dispersed treated water; when a continuous flow process is introduced a flow meter on the discharge line will be required to indicate volumes, and
 - xi. dimensioned location of trailer.
- 9. the development meeting Mount Pearl Development Regulations 2010; and
- 10. the waste water that is stored and treated on site that enters the City sanitary sewer system shall be metered and charged on the basis of the additional waste water entering the City's system. The calculation of the fees charged will be determined by the Department of Corporate Services.

<u>Discussion:</u> The following points were raised and clarified:

- On-site trailer would be a permanent fixture.
- Quality control measures are in place (ongoing testing) to ensure the environment is protected.
- Should there be environmental problems; the Department of Environment & Conservation would require corrective action by the applicant.
- Condition with respect to fees associated with additional waste water entering City's system to be added to development permit.

Question called. Motion carried unanimously.

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and Council's public notification policy, he will, at a regular meeting of Council, move that the Mount Pearl Adult Materials Display Regulations as adopted by Council on September 4, 2007 be revoked. The reason for the revocation is that, as a result of Council's regulatory review process, it was determined that the regulation of such materials is beyond the scope of Council's legislative authority.

Councillor Tessier gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and Council's public notification policy, she will, at a regular meeting of Council, move an amendment to the text of the Mount Pearl Taxi Regulations that, if enacted, will:

1. Add, change and clarify a number of clauses that reference the definitions; licenses, inspections, cruising, fares and tariff rates;

The purpose of this proposed amendment is to update Council's authority to regulate the taxi services throughout the City.

Councillor Tessier gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and Council's public notification policy, she will, at a regular meeting of Council, move an amendment to the text of the Mount Pearl Traffic Regulations that, if enacted, will:

1. Add, change and clarify a number of clauses that reference the commercial motor vehicle, speed limit provision and definitions;

The purpose of this proposed amendment is to clarify Council's authority to regulate the traffic services throughout the City.

14-04-237 <u>Citizen of the Year</u>

Members of council extended congratulations to Claudette Coombs on being chosen the 2013 Citizen of the Year. Nominees – Cheryl Ash, Brian Hunt and Patrick O'Keefe Sr. were also recognized and congratulated. Appreciation was extended to all volunteers, the Kinsmen Club and City staff.

Condolences were extended to Gerald and Claudette Coombs on the passing of their son, Stephen.

14-04-239 <u>Congratulations – Victoria Jackman</u>

Deputy Mayor Locke congratulated Victoria Jackman, a Mount Pearl Senior High student, who received the Vimy Pilgrimage Award (one of twenty students across Canada). The Award consists of a fully funded, week-long educational program in Europe to study Canada's tremendous First World War effort.
