PLANNING AND DEVELOPMENT COMMITTEE

17-08-397 <u>Cease and Desist Order – Yard Sale and Property Maintenance</u> <u>106 Park Avenue</u>

Motion – Councillor Walsh/Councillor Ledwell

RESOLVED THAT an Order be issued to the property owner of 106 Park Avenue, in accordance with the City of Mount Pearl Act, the Urban and Rural Planning Act, the City of Mount Pearl Development Regulations, and the Occupancy and Maintenance Regulations, to cease the yard sales and the yard be cleared of all items by Friday, August 11, 2017 or City staff or a contractor will be used to correct the situation with the property owner to be billed for the expenses.

17-08-398 Application for Subdivision and Consolidation Redwood Management Ltd. / Prospect Development Ltd. Brant Drive - Kenmount Road Area

RESOLVED THAT the development application by Redwood Management Ltd., co-signed by Prospect Development Limited, for the proposed subdivision and consolidation of land associated with three parcels of land in the Brant Drive / Kenmount Road area, be approved and that a Subdivision Development Permit be issued, subject to conditions outlined in the Planning & Development Committee report dated July 26, 2017.

17-08-399 <u>Liquid Blending Facility (Mud Plant)</u> Stantec (on behalf of Halliburton) <u>30 Kyle Avenue</u>

RESOLVED THAT an application by Stantec, on behalf of Halliburton Group Canada, to develop a liquid mud plant at 30 Kyle Avenue be approved and a development permit be issued subject to the following conditions:

- 1. the development is required to meet the Mount Pearl Development Regulations 2010 and all other related regulations and legislation;
- 2. the total hazardous storage volume capacity to be confirmed by Pardy's and forwarded to the City for verification;
- 3. Engineering Services final approval and conditions;
- 4. St. John's Regional Fire Department conditions;

- 5. Newfoundland Power's conditions;
- 6. Planning and Development Department's conditions;
- 7. Department of Municipal Affairs and Environment release conditions of approval; and
- 8. if there is any change or intensification of the use, then a new development application would need to be submitted to the City for review and approval.

17-08-400 <u>Mount Pearl Development Regulations 2010 Amendment No. 62, 2017</u> <u>Pet Crematorium Amendment</u>

RESOLVED THAT the Mount Pearl Development Regulations 2010 Amendment No.62, 2017 (Pet Crematorium Amendment), as presented, be adopted and submitted to the Department of Municipal Affairs and Environment for registration.

17-08-401 <u>Residential Subdivision of Land (2 Single Family Lots) – DA17-0317</u> 58582 NL & LAB Inc. (Kento Windows) 13 Mount Carson Place

RESOLVED THAT the application to subdivide the lot at 13 Mount Carson Place, to create two (2) residential lots for the purposes of the existing single dwelling to remain on the west lot and a new single dwelling be constructed on the east lot be approved and that a subdivision development permit be issued subject to the following conditions:

- 1. the new lot shall have the civic address 35 Mount Carson Place;
- 2. Newfoundland Power's conditions;
- 3. Engineering Services Division's conditions;
- 4. Finance Division's conditions;
- 5. Planning and Development Department's conditions; and
- 6. the development meeting the Mount Pearl Development Regulations 2010.

17-08-402 <u>Alternate Landscaping Proposal</u> <u>16 Stonegate Crescent</u>

RESOLVED THAT the alternate landscape design for the rear yard at 16 Stonegate Crescent be approved AND FURTHER THAT the north side yard, which now contains pea gravel, be properly finished with hard surface material that will accommodate vehicular traffic.

NEW BUSINESS

17-08-405 Open Air Fireplaces

Councillor Walsh advised of a complaint regarding open air fireplaces, noting that it had been referred to the Planning & Development Committee for review and subsequent report. He noted that the matter of banning these fireplaces had been previously investigated but the research didn't support an outright ban. When a complaint is received, the matter is referred to the municipal enforcement division for follow up (which was done in this case).

17-08-406 <u>City Days</u>

Councillor Tessier, along with other members of Council, extended appreciation to City staff and volunteers on a successful City Days celebration. It was noted that the venue (Ruth Avenue Sportsplex) for the Sunday concert was a great site for the event as it provided ample parking and space. Councillor Aker advised that some residents believe the concert should be moved back to St. David's

Park. Councillor Ledwell did not support the St. David's site given the significance of the war memorial/cenotaph.

17-08-407 <u>Condolences – Dave Legrow</u>

Members of Council extended sincere condolences to the family and friends of Dave Legrow who recently passed away. Mr. Legrow's volunteerism with the soccer community was acknowledged.

17-08-408 Harnum Crescent – Discolored Water

Residents of Harnum Crescent were advised that the discolored water was related to a flushing issue and is being investigated by staff. It is anticipated that the matter should be resolved within a few days. Appreciation was extended to IPW staff for addressing the matter quickly.

17-08-409 Congratulations – Kate Sullivan

On behalf of Council, Councillor Ledwell extended congratulations to Kate Sullivan, a member of the Marlins Swim Club, on winning three medals (gold, silver and bronze) at the Canadian Junior National Games.

17-08-410 <u>Congratulations – Daniel Kelloway</u>

On behalf of Council, Councillor Ledwell extended congratulations to Mount Pearl resident, Daniel Kelloway, who placed sixth in the 400m final at the World Francophone Games.

17-08-411 Men's Slo-Pitch Softball Club

Councillor Stoyles extended congratulations to the Men's Slo-Pitch Softball Club on their 40th anniversary.

17-08-412 Arts Carnival – Association for the Arts in Mount Pearl (AAMP)
