2013/2014 Winter Salt

RESOLVED THAT the contract for the supply of salt for 2013-2014 be awarded to the lowest, compliant bidder, Avalon Coal, Salt & Oil Ltd., as follows:

• Up to 8,500 tonnes at the unit price of \$94.43 per tonne for a total of up to \$802,655 plus HST.

- 1. Submission of revised engineering plans for review and approval prior to issuance of building permit reflecting content of the City's emails of July 25, 2013 and August 1, 2013;
- 2. Site, access, grading, and servicing plans to meet the requirements and approval of the Planning and Development Department and the Engineering Services Division prior to any building permits being issued;
- 3. All conditions of the Provincial Department of Environment & Conservation, including the Department's Permit to Alter A Body of Water dated March 13, 2013;
- 4. All conditions of the Federal Department of Fisheries & Oceans, as per the Department's letter of March 4, 2013;
- 5. Submission of a copy of Deed of Conveyance of property from Principle Holdings Ltd. prior to the issuance of a building permit;
- 6. Signing of a joint access agreement between Seaforce Properties, Principal Holdings Ltd., and the City of Mount Pearl prior to issuance of building permit;
- 7. Any easement/access requirements to detention pond by City resolved to the City's satisfaction prior to the issuance of a building permit;
- 8. Identification of truck routes/traffic control plan/disposal sites; and
- 9. The issuance of a building permits prior to any construction commencing on site.

<u>Amendment – Mount Pearl Development Regulations 2010</u>

Councillor Aker gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will:

Amend Map 1 – Land Use Zoning Map as follows:

Rezone a portion of property situated at the south side of Park Avenue, immediately east of the property at 59 Park Avenue, and immediately west of the provincial T'Railway corridor from Open Space (OS) to Residential – Medium Density (RMD).

The purpose of this proposed amendment is to provide Council with the authority to consider a multi-unit residential development fronting onto Worrall Crescent.
