Information was provided on various ongoing multiyear capital works projects. It was indicated that the Reid Community Centre will remain open for bookings until mid-April. The project is forecasted to start in April and finish in August and will not impact staffing levels.

# 16-02-120 Public Works

It was noted that winter maintenance is ongoing that includes removal and/or clearing of snow and ice in advance of above freezing temperatures to mitigate localized flooding and potential subsequent severe ice buildup. Snow dumping at Team Gushue site has been restricted to daytime hours. Extensive freeze/thaw conditions create challenges to ensure adequate ice control, and also create conditions that increase development of potholes.

# 16-02-121 <u>Contract Recommendation – Planting & Maintenance</u> <u>Hanging Floral Baskets & Planters</u>

# 16-02-124 Ruth Avenue between Old Placentia Road and Pitts Memorial Drive Proposed Road Improvements

For the information of the public, the City of Mount Pearl has engaged Harbourside Transportation Consultants to undertake a city wide comprehensive transportation study. While the work is ongoing and not complete, the consultant has reviewed specific roadways and intersections within Mount Pearl that are considered priorities and needed a more immediate review prior to the completion of the study.

One of these roads is Ruth Avenue primarily the section between Old Placentia Road and Pitts Memorial Drive. This road is a priority as in 2013 the City of St. John's provided the City with the Galway Traffic Impact Study which was prepared by Hatch Mott Macdonald indicating that the development of Galway would significantly increase traffic flows along Ruth Avenue between Old Placentia Road and Pitts Memorial Drive. Based on the modeling and Level of Service analysis in the report, Hatch Mott MacDonald recommended that the portion of Ruth Avenue between the Pitts Memorial Drive Interchange and Old Placentia Road be significantly improved. The road network improvements proposed along Ruth Avenue involve a series of roundabouts at Old Placentia Road and Pitts Memorial Drive, eliminating the intersection at Olympic Drive and channelization of Ruth Avenue through the construction of a centre line median or barrier.

Motion – Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT the following action be approved:

- 1. Work be undertaken to determine the costs of the proposed improvements;
- 2. The City prepare a public engagement strategy to inform the public about the improvements, receive feedback on the implications of the proposal and prepare a report for Council's information; and,
- 3. City staff meet with the City of St. John's to commence discussions regarding the responsibility for the costs to undertake the improvements along Ruth Avenue to accommodate the Galway development.

Discussion ensued regarding the impact of the Galway development on the City (i.e. sanitary sewer, water supply, road network) and the associated costs. The purpose of this report was to ensure the public was aware of the proposed changes.
