## 16-01-003 <u>Mount Pearl Development Regulations 2010 Amendment</u> Mini-Split Heat Pump Amendment

Council was advised that the registered amendment (mini-split heat pump) has not been received from the Department of Municipal Affairs. Upon receipt, applicable residents will be notified of the change. Councillor Walsh advised that he had contacted property owners who had an interest in the amendment.

## PLANNING AND DEVELOPMENT COMMITTEE

#### 16-01-004 Property Encroachment – 6 Emberley Place

Motion – Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT a request to purchase a portion of City property adjacent to 6 Emberley Place be denied, however, approval be granted to enter into an agreement (license to occupy) with the property owner.

<u>Discussion</u>: It was noted that the execution of this agreement will not impact any changes to the Team Gushue Complex site.

Question called. Motion carried unanimously.

16-01-005 Commissioner's Report <u>Mount Pearl Municipal Plan 2010 Amendment No. 15, 2015 &</u> <u>Mount Pearl Development Regulation 2010 Amendment No. 48, 2015</u> (16 -24 Glendale Avenue Amendment)

It was noted that Commissioner Clinton's report with respect to the proposed amendments for the 16 – 24 Glendale Avenue development was received. After reading and hearing the various written and verbal representations presented at the December 10 public hearing, the Commissioner recommended approval of

the Mount Pearl Municipal Plan 2010 Amendment No. 15, 2015 and Mount Pearl Development Regulation 2010 Amendment No. 48, 2015 without amendment.

Motion – Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT Mount Pearl Municipal Plan 2010 Amendment No. 15, 2015 and Mount Pearl Development Regulation 2010 Amendment No. 48, 2015 be approved and forwarded to the Department of Municipal Affairs for registration AND FURTHER THAT the Commissioner's report be posted on the City's website.

Discussion: It was noted that the Commissioner included in his report that he was satisfied that Council followed the process set out in the Urban and Rural Planning Act for the preparation, consultation, notification and the holding of the public hearing. He further indicated that Council took steps above and beyond what was required and appeared to have bent over backwards to deal with and clarify the concerns raised by residents. The report confirms that Council did due diligence to process the request to amend the Mount Pearl Municipal Plan and Development Regulations to accommodate a proposal for a 3 - 4 storey 60 unit condominium apartment building at 16 - 24 Glendale Avenue.

It was indicated that following the publication of the amendment in the Newfoundland Gazette and after the notice of registration has been received from the Department of Municipal Affairs; the development proposal would be presented to Council for consideration.

Question called. Motion carried unanimously.

16-01-006 Crown Land - East of 1221 Topsail Road City of Mount Pearl (Crown Land for municipal use) Municipal Recommendation Form for Crown Land Application Commercial - Mixed (CM) and Conservation (CON) Use Zone

Motion – Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT approval be granted to proceed with an application to Crown Land for the transfer of ownership of land east of 1221 Topsail Road to the City of Mount Pearl for public walkway access purposes.

Question called. Motion carried unanimously.

16-01-007 <u>Winsor Homes</u> <u>Proposed Ground Sign Location</u> <u>1027 Topsail Road</u>

Motion – Deputy Mayor Locke/Councillor Walsh

RESOLVED THAT an application from Winsor Homes to erect a ground/pylon sign in the front yard of property at 1027 Topsail Road provided it is outside of the Newfoundland Power easement be approved.

<u>Discussion</u>: It was noted there is an approximate 19 feet public right of way between the carriageway of Topsail Road and the property's front property line. While the property owner has sufficient green space available at the corner of Marlin Street and Topsail Road to locate the proposed sign, the property owner did not wish to locate the proposed ground sign there as it will be obstructed by other nearby signs including the subdivision gateway sign in the area. It was clarified that sight lines are not impeded and there is no adverse impact to place the sign in this location.
