## 14-01-014 Winter Maintenance

An update on snow clearing operations was provided. Appreciation was extended to residents who have removed snow around their neighbourhood fire hydrant. As a result of the December snowfall, the 2013 snowclearing budget was over by approximately 12% and it's about 15% (normally would be 10%) through the 2014 budget.

## 14-01-015 Multiplex

The public was advised that the multiplex is 85% financially complete.

# 14-01-016 Solid Waste Management Schedule 2014

The public was advised that the solid waste collection schedule has been delivered to residents of Mount Pearl via Canada Post. The schedule reflects the recent changes in bulk garbage collection which will see prescheduled collections during April/May and September/October. During the months of June, July and August residents can request a maximum of two bulk collections free of charge. Residents are required to contact the Department of Infrastructure & Public Works to schedule a pick-up. Additional collections outside of the scheduled pick-ups can be arranged at a charge of \$45.00.

#### PLANNING AND DEVELOPMENT COMMITTEE

14-01-017 Mount Pearl Municipal Plan 2010 Amendment No. 7, 2013

Mount Pearl Development Regulations 2010 Amendment No. 26, 2013

(Wilkes Avenue Amendment)

RESOLVED THAT pursuant to the Urban and Rural Planning Act, the Mount Pearl Municipal Plan 2010 Amendment No. 7, 2013, and Mount Pearl Development Regulations 2010 Amendment No. 26, 2013 (Wilkes Avenue Amendment) be approved as presented.

<u>Discussion:</u> The purpose of the amendment is to have the entire area of the proposed residential lots on the north side of a new subdivision street named Wilkes Avenue entirely within the Residential designation and RSU-3 zoning in order to permit the residential development of these lots.

14-01-018 Mount Pearl Municipal Plan 2010, Amendment No. 8, 2014

Mount Pearl Development Regulations 2010, Amendment No. 27, 2014

(959-963 Topsail Road Amendment)

RESOLVED THAT pursuant to the Urban and Rural Planning Act, the Mount Pearl Municipal Plan 2010 Amendment No. 8, 2014 and Mount Pearl Development Regulations 2010 Amendment No. 27, 2014 (959-963 Topsail Road Amendment) be adopted AND FURTHER THAT a public hearing be scheduled for February 4, 2014, with Mr. Ernest Boone as Public Hearing Commissioner.

<u>Discussion:</u> The purpose of the amendment is to relocate the designation and zoning boundary to fully include the rear yards of these properties up to the limit of the top of the slope into the Commercial Mix use zone for the purpose of bringing the designation and zoning boundary in line with the existing topography of these properties and to provide the Council with the authority to consider the proposed expansion of an existing gravel equipment and storage yard.

# 14-01-019 Appeal of City of Mount Pearl Order Regarding Alternate Landscaping 14 Samson Street

Council was advised that the Appeal Board ruled that the City had the authority to issue the Order to the property owner of 14 Samson Street to remove the stone from his property and replace it with topsoil and grass sod.

RESOLVED THAT the property owner, 14 Samson Street, be advised that, based on the Appeal Board Hearing Report, he must comply with the requirement of the original Order dated July 5, 2013, but that, in consideration of the winter weather, the Order be revised to extend the deadline for completion of work to June 15, 2014.

<u>Discussion:</u> Council was advised that prior to the Order being issued, the property owner had been requested to submit a (professional) landscaping plan but it was not received. It was acknowledged that the property owner still has the opportunity to submit a landscaping plan (prepared by a professional) but the work is to be completed by the deadline (June 15, 2014).

# 14-01-020 Petition by Residents of Pinware Crescent Regarding Permit to Construct Driveway at 13 Pinware Crescent

Council was advised of a petition opposing the construction of a parking space at 13 Pinware Crescent. This matter is currently under appeal therefore the City does not have the legislative authority to respond to or act upon this petition until such time as the Appeal Board Hearing has been held and a decision rendered.
