Mayor Simms welcomed Constable John Tucker who was to be sworn in as a Municipal Enforcement Officer. Mayor Simms and Superintendent Blair Tilley officiated in the Swearing-In-Ceremony of Constable Tucker.

13-01-030 <u>Presentation – Municipal Long Service Award</u>

PUBLIC WORKS COMMITTEE REPORT

13-01-032 Winter Maintenance Update

An update following the snow storm of January 11 of action taken by City crews was presented. Residents were reminded of the following:

- No parking of vehicles on streets during snow storms or 12 hours thereafter.
- No parking of vehicles on streets between the hours of 1:00 AM and 8:00 AM from December 1 March 31 (inclusive).

- Snow cannot be shoveled, plowed, or blown from a driveway or parking lot onto any street within the City. Particular reference was made to some private snowclearing contractors who do this.
- Snowmobiles are not permitted to be used within City boundaries.

It was noted that the above violations are ticketable offences.

Appreciation was extended to snowclearing staff for their efforts during this significant weather event.

PLANNING AND LAND USE DEVELOPMENT COMMITTEE

13-01-033 <u>Application for Billboard - E.C. Boone</u> 7 Old Placentia Road

Motion - Councillor Aker/Councillor Ledwell

RESOLVED THAT a development application by E. C. Boone to erect an illuminated billboard sign on the property at 7 Old Placentia Road be approved and a development permit issued subject to the following conditions:

- 1. More detailed site plan illustrating location of distribution line and minimum required setbacks, as per Newfoundland Power conditions.
- 2. Conditions expressed by the City Inspector.
- 3. Conditions expressed by Newfoundland Power. Final letter of approval by Newfoundland Power required.
- 4. Conditions expressed by the Engineering Services Division of the Department of Infrastructure & Public Works, including but not limited to:
 - The proponent is to check with NL Power if they require electrical servicing. This is to occur prior to any building permits being issued.
 - Further information is required prior to any building permits being issued regarding the proposed servicing of the sign (installation, repair/maintenance) as there is no access to lot.
- 5. Drawings stamped and signed by professional engineer.

Question called. Motion carried with Councillor Stoyles abstaining from voting due to a conflict of interest.

13-01-034 <u>Proposed Single Family Dwelling Development</u> 28 Mount Carson Avenue

RESOLVED THAT an application for a single-family dwelling development at 28 Mount Carson Avenue be refused on the basis of prohibiting any further accesses

onto Mount Carson Avenue, which is in keeping with the approved Comprehensive Development Scheme (CDA) for this area.

<u>Discussion:</u> Council advised that the recent approval of another application for a development on Mount Carson Avenue was made on the basis of the owner having owned the land prior to the approved CDA. Council does not want further accesses off Mount Carson Avenue and noted that Macroom Place has to be developed before further consideration could be given to the application in question.

Regarding 30A Forest Avenue

RESOLVED THAT the Order issued on January 10, 2013 to the property owner of 30A Forest Street in relation to the placement or erection of a building on the property without a municipal permit be ratified.

<u>Discussion:</u> It was noted that the property owner previously made application to build a dwelling on the property and it was denied. The owner filed an appeal against Council's decision. He is now requesting approval to leave the shed until the appeal is heard. Council noted that the shed was placed on the property after the appeal was filed and done without a permit. Council confirmed the Order for the shed to be removed.
