ENGINEERING SERVICES COMMITTEE

12-01-040 <u>Fleet Street – Review of On-Street Parking Issue</u>

Council was advised of an inquiry from a resident of Fleet Street requesting clarification regarding the placement of "no parking" signs in the area of #2-#18 Fleet Street.

It was noted that Engineering staff visited Fleet Street and confirmed that the street width is inadequate to permit parking on both sides of the street. For safety reasons, the "no parking" signs were placed on the even side of the street, on the inside of two curves. This location was considered the preferred area to prevent sightline issues for motorists.

It was noted that lawns damaged by the installation of the signs/poles will be repaired following the winter season.

RESOLVED THAT an application by David Manuel to occupy a portion of the dwelling at 86 Nash Crescent to operate a Home Occupation (re-cover furniture) be refused on the basis that the proposed use is not in the form of a small appliance repair, sporting goods, educational or similar use as per Section 7 – Special Developments, 7.16 Home Occupation, Condition 7.16.1.

<u>Discussion:</u> Council questioned the proposed use and whether it could be discretionary if there was no objection in the neighbourhood. It was agreed that

the motion denying this application would stand; however, the regulations will be reviewed with consideration being given to permitting discretionary uses.

Amendment – Mount Pearl Development Regulations 1988

Councillor Aker gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will:

 Amend the land use zoning map of the Mount Pearl Development Regulations 2010 by rezoning land in the Kenmount Hill area from Rural to Urban Reserve – Comprehensive Development Area.

The intention of this amendment is to rezone those lands currently zoned as Rural and located above the 190 m contour to an urban zoning to signal Council's intention to encourage the development of these lands for urban purposes subject to the approval of a detailed comprehensive development scheme and provided adequate municipal services is in place to accommodate the urbanization of these lands.

Those lands not being re-zoned shall maintain their present zoning.

Councillor Walsh extended appreciation to staff in recognition of their quick and efficient response during and following the recent storm.

12-01-050 Condolences

Councillor Stoyles extended condolences to City employee, Gordon Collins, on the passing of his mother.

12-01-051 <u>Minor Hockey Week</u>

Councillor Stoyles advised that she attended the opening ceremonies of the Novice Jamboree and Kick-Off of Minor Hockey Week 2012.

12-01-052 Residential Energy Efficiency Program (NLHC)

Councillor Stoyles extended appreciation to MHA Paul Lane for forwarding information on the above noted program to his constituents.

12-01-053 <u>Team Gushue Highway – Construction</u>

Councillor Stoyles noted that MHA Steve Kent has advised that construction has begun on the first phase of the extension to the Team Gushue Highway which is expected to be completed in 2014.

12-01-054 Regulations – Fireworks

Deputy Mayor Locke raised concerns expressed by residents regarding the effects of fireworks on pedestrians and animals. He questioned the possibility of regulating their use. It was noted that the City has previously considered regulations but not implemented them. It was requested that staff revisit the matter.

12-01-055 Team Gushue Highway

Deputy Mayor Locke commented on the potential for traffic congestion from the off ramp for Team Gushue Highway/Topsail Road/Mount Pearl Square. It was indicated that staff have brought this matter to the attention of Government officials.

12-01-056 <u>Mount Pearl Minor Hockey Association – Volunteer Appreciation</u>

Deputy Mayor Locke advised that he attended the MPMHA Volunteer Appreciation Dinner. He extended appreciation to all the volunteers (executive, coaches, parents, referees) involved in the sport.

12-01-057 Animal Care

Councillor Tessier encouraged residents not to leave their pets out in the cold for extended periods of time, noting that the SPCA has indicated that shelters should be insulated. She also indicated that no animal is permitted to roam freely.

12-01-058 Garbage Collection

Councillor Tessier reminded residents that garbage is to be placed to the curb by 8:00 am on the day of collection regardless of the time it is usually collected.

12-01-059 <u>Trails – Groomed</u>

In response to Councillor Aker, it was noted that the trail grooming program has commenced and to date the trail from Donovan's to Dunn's Road has been groomed.

12-01-060 Affordable Seniors Housing Committee

Councillor Aker advised that the Affordable Seniors Housing Committee, in conjunction with the Seniors Independence Group, will be hosting a pancake lunch on February 15 at Park Place Community Centre. This is a fundraiser in support of the Newfoundland and Labrador Housing and Homelessness Network.
