RESOLVED THAT the City of Mount Pearl agrees to comply with the Department of Environment and Conservation's Flood Plain Management Policy in regulating development in the Waterford River Area as part of the proposed study.

TRANSPORTATION & PUBLIC SAFETY COMMITTEE

15-07-464 <u>Proposed Amendments</u> <u>Bicycle, Scooter, Skateboard and Similar Objects Regulations</u>

Motion – Councillor Tessier/Councillor Ledwell

RESOLVED THAT the following amendments to the Bicycle, Scooter, Skateboard and Similar Objects Regulations be adopted:

- (a) general formatting, reorganizing and rewording;
- (b) to change the definition of *"bicycle, scooter, skateboard or similar object"* to mean any devise propelled on wheels by human power;
- (c) a person is **exempted** from Section 3 ("no person shall ride or operate a bicycle scooter, skateboard or similar object on a street unless that person is wearing a helmet and the chinstrap of the helmet is fastened under the person's chin"):
 - (1) is a member of a religious community who, in accordance with his or her beliefs, is required to wear religious headwear; or
 - (2) cannot wear a bicycle helmet for medical reasons and has provided the City with written confirmation of same from a licensed physician.
- (d) to change the age of a person required to wear a helmet to sixteen;

(e) to increase the conviction fine to \$50.00;

<u>Discussion</u>: The purpose of the amendment is to add, change and clarify a number of clauses that reference the definitions, licenses, requirements and enforcement, clarify Council's authority to regulate the Bicycle, Scooter, Skateboard and Similar Objects throughout the City and to adjust the penalties for non-compliance.

Question called. Motion carried unanimously.

15-07-465 Speeding Traffic Concerns within City Limits

For the information of the public, there have been complaints indicating that speeding in residential areas is excessive. The Municipal Enforcement Division will continue to monitor traffic through data collected from street radar signs. Municipal Enforcement Officers will also continue to monitor streets and violators will be ticketed.

15-07-466 <u>Tely 10 Road Race</u> Sunday, July 26, 2015

The public was advised to expect possible traffic disruptions as a result of the Tely 10 Road Race taking placing on Sunday, July 26.

15-07-467 <u>Holy Sepulchre Service</u> <u>Tuesday, July 28, 2014</u>

The public was advised that the Holy Sepulchre annual service will be held on July 28 at 7:00 pm which may impact traffic in that area.

NEW BUSINESS

15-07-468 Lights on Michener Avenue and Ruth Avenue

Deputy Mayor Locke raised concerns regarding the above noted intersection, in particular, the simultaneous green traffic light and pedestrian walk signals. The matter was referred to staff to see if this issue could be resolved before the school year begins in September.

15-07-469 <u>Positive Praising</u>

Councillor Tessier encouraged residents to start "positive praising" on social media for good deeds done instead of "public shaming", in particular regarding littering on City streets.

15-07-470 Animal Control

Councillor Tessier acknowledged employee, Walter Fowler, for his prompt attention to an Animal Control matter this past week.

15-07-471 Utility Boxes

Councillor Tessier advised that the painting of the utility boxes is continuing over the summer months.

15-07-472 Retirement

Council congratulated Gail Sexton, Human Resources Assistant on her retirement effective Friday, July 17. She has been an employee of the City for 21 years.

15-07-473 Botanical Gardens

Councillor Aker reminded residents of the Mystery Garden Tour taking place this coming weekend at the Botanical Gardens. There will be 10 participants with one being from Mount Pearl.

15-07-474 <u>Sympathy</u>

Sympathy was extended to families of Margaret Grant and Ken Ryan on their passing. They were two long-time Mount Pearl residents.

15-07-475 Open Area on Brookfield Avenue/Commonwealth Avenue

Councillor Stoyles received complaints about the debris that is being dumped on the corner lot of Brookfield Road and Commonwealth Avenue. It was requested that staff follow up with the City of St. John's on this issue.

15-07-476 Knights of Columbus – Father J.B. Kent Council

Councillor Ledwell extended congratulations to the Knights of Columbus on a successful year and to the outgoing Grand Knight, Mike Hussey and the incoming Grand Knight, Matt White.
