John Sloan, John Carew and Officer Cadet Harry Little who participated as a show of support for the Canadian Forces members still stationed in Afghanistan. Congratulations were extended to all.

10-07-572 <u>Molson Provincial Senior Semi-Finals</u>

Councillor Aker extended congratulations to the Mount Pearl Blazers who defeated the Pasadena Pirates to win the Molson Provincial Senior A semifinal series three games to one. The Blazers now advance to the Senior A finals against the St. John's Capitals. Mount Pearl plays St. John's next weekend (July 31-August1) at St. Pat's Ball Park in the first three games of the best four of seven game finals. Game four and games five to seven, if necessary, will be played on the August 7-8 weekend at Smallwood Drive Field in Mount Pearl. He encouraged residents to show their support for the Blazers.

10-07-573 <u>Team Gushue Synthetic Turf International Soccer Field</u>

Councillor Walsh advised that the official opening of the Team Gushue Synthetic Turf International Soccer Field is scheduled for 7:00 pm on July 29. He noted that representatives from the Provincial and Federal Governments will be in attendance.

Councillor Stoyles reminded motorists that the Holy Sepulchre Cemetery mass was scheduled for this evening (July 27) and that traffic delays were possible.

10-07-575 East West North Summer Expo

Councillor Stoyles commented on the success of the Expo (both in Mount Pearl and Corner Brook) and City Days' events.

10-07-576 <u>Hogweed</u>

Councillor Lane asked that the Infrastructure & Public Works Committee consider a policy addressing protocol to remove hogweed on public and private properties. He also requested that the matter be referred to the Minister of Environment & Conservation.

In response to Deputy Mayor Locke, it was noted that streets are upgraded/paved during daylight hours for a number of reasons, those being – cost, safety, location, and climate.

10-07-580 Farrell Drive

Deputy Mayor Locke advised of a resident of Farrell Drive has difficulty exiting her driveway due to the location of the driveway and the speed of oncoming traffic. It was requested that the Infrastructure & Public Works Department review the property with consideration being given to erecting a mirror that would provide an improved line of sight for the property owner (similar to that in use in other municipal jurisdictions to improve sight lines).

10-07-581 Bicycles

Deputy Mayor Locke requested that the Community Services Committee consider the possibility of providing bicyclists with bells to alert walkers/joggers when using the trailway system.

10-07-582 <u>East West North Summer Expo</u>

Mayor Simms commented on the success of the Expo in Corner Brook, noting that he and Councillor Stoyles participated in various ceremonies and events. He noted that the location of their event is excellent and well laid out.
