# **CORRESPONDENCE**

# 13-06-460 <u>Department of Environment & Conservation – Office of the Minister</u> NORM Decontamination & Temporary Storage Facility

A letter was presented from the Honourable Tom Hedderson advising that legislation does not permit the appointment of a representative from the City of Mount Pearl to the Environmental Assessment Committee. The regulations stipulate that members of the Environmental Assessment Committee shall be provincial or federal government employees.

Mayor Simms challenged the decision on the premise that the City of Mount Pearl is an employee of the province and part of an order of government called the Province of Newfoundland and Labrador.

It was noted that the Director of Planning & Development will take the lead role on following the application process through the Committee. It was further noted that it will provide the City the opportunity to demonstrate the zoning in this area.

Council was also advised of an offer of assistance from Gordon Cooper, a resident who has knowledge of environmental matters.

#### PUBLIC WORKS COMMITTEE

# 13-06-461 <u>Household Hazardous Waste Day (Information)</u>

Household hazardous waste collection for the City of Mount Pearl took place on June 8 with 39 vehicles visiting the Municipal Depot to dispose of items such as batteries, household paint, pesticides and waste oil. It was noted that the number of participants was lower than in previous years which may be due to the availability of a facility at the landfill site. Residents were reminded not to dispose of hazardous waste with their regular household garbage. # 13-06-462 <u>Summer Maintenance (update)</u>

An update on the City's summer maintenance program was provided, i.e. street cleaning, garbage collection along trails, etc. It was noted that there is limited equipment (one street sweeper, one madvac) available for picking up litter. It was requested that the Community Services (municipal enforcement) consider ways to deal with the flagrant disregard for littering. It was also noted that the Green Team will be working with businesses to develop a solution to flyer debris.

Animal refuse bags have been installed in various locations along the trails and parks. It was suggested that consideration be given to placing the bags at the entrance to Squires Field, Team Gushue Complex, as well as various locations where the trails meet the streets.

Snow clearing damages are being assessed and work orders have been prepared for remedial action.

#### 13-06-470 Multiplex - Update

# 13-06-472 <u>Application for Driveway Extension</u> 13 Seabright Place

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT the application for a driveway extension at 13 Seabright Place be refused as it would result in the reduction in the landscaped front yard to less than 50% of the front yard which is contrary to Regulation 16.19.3(b) of the Mount Pearl Development Regulations.

<u>Discussion:</u> Councillor Stoyles requested that consideration be given to permitting the extension given the limited parking availability for townhouses. Councillor Stoyles' motion to defer the decision was defeated as there was no seconder.

It was acknowledged that similar requests have also been refused and to approve this application would establish a precedent for future requests. It was agreed that the Planning & Land Use Committee would review the landscape standards, the Public Council Meeting June 25, 2013 Page 7

number of semi-detached units and previous applications in recognition of developments such as apartment buildings and condominiums.

Question called. Motion carried with Councillor Stoyles voting against the motion.

13-06-473 Mount Pearl Municipal Plan 2010 Amendment No. 5, 2013 and Mount Pearl Development Regulations 2010 Amendment No. 18, 2013 (912-924 Topsail Road Amendment)

Motion - Councillor Aker/Councillor Ledwell

RESOLVED THAT Mount Pearl Municipal Plan Amendment No: 5, 2013 and Development Regulations Amendment No: 18, 2013 (912-924 Topsail Road Amendment) be adopted AND FURTHER THAT Jody Saunders be appointed as Commissioner for the public hearing scheduled for July 17, 2013, 7:00 pm at Mount Pearl City Hall.

<u>Discussion</u>: It was noted that the purpose of the proposed amendment is to provide Council with the authority to consider an application to redevelop the property and renovate the existing building which was formerly used as strip mall to an automotive display and sales use at 912-924 Topsail Road.

13-06-474 City of St. John's Referral

<u>Proposed Amendment to the City of St. John's Municipal Plan</u> <u>Rezoning for a Proposed Industrial Commercial Park – Kenmount Road</u>

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT a response be forwarded to the City of St. John's advising that the City of Mount Pearl has no objections to the proposed amendment to the City of St. John's Development Regulations as outlined in their letter of May 3, 2013; and further, that the City of St. John's be advised of the location of the proposed Pearlview West road connection at this location and the access design of the subdivision take this into consideration.

<u>Discussion:</u> Council expressed concern that the development would require on-site services until such time as municipal water and sewer services would be available. It was agreed that the matter would be deferred to allow for the preparation of a letter outlining Council's concern for this standard of development.

<u>Motion to Defer</u> – Councillor Stoyles/Councillor Ledwell

RESOLVED THAT the response to the City of St. John's regarding an application to rezone a parcel of land on the north side of Kenmount Road to allow for the construction of an industrial commercial subdivision be deferred.

Question called. Motion carried unanimously.

13-06-475 Proposed Mount Pearl Development Regulations 2010 Amendment No. 19, 2013
Conservation Use Zone Amendment

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT the proposed Mount Pearl Development Regulation 2010 Amendment No. 19, 2013 be adopted.

<u>Discussion:</u> The purpose of the proposed amendment is to have the permitted uses of the Conservation use consistent with Subsection 6.14 – Flood Risk Corridor, which permits roads and associated structures. It was clarified that this amendment relates to non-building (driveways, parking lots) uses such as roads and associated structures. It was also noted that all development applications located within the flood way, floodway fringe and buffer are referred to the Provincial Department of Environment & Conservation. With respect to Council's inquiry regarding the City's liability should personal property (located on a non-building use) be damaged, it was requested that legal clarification be obtained.

Question called. Motion carried unanimously.

13-06-476 Proposed Mount Pearl Development Regulations 2010 Amendment No. 20, 2013
CG Apartment Building Amendment

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT the proposed Mount Pearl Development Regulation 2010 Amendment No. 20, 2013 be adopted.

<u>Discussion:</u> The purpose of the proposed amendment is to correspond with the General Commercial policy 6.2.5(vi) of the Mount Pearl Municipal Plan 2010 which states "... and apartment buildings may be permitted in appropriate areas of General Commercial designation".

<u>Discussion:</u> It was clarified that this amendment does not impact Council's discretionary authority.

Question called. Motion carried unanimously.

# 13-06-477 <u>Alternate Landscaping for Front Yard</u> 14 Samson Street

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT an Order be issued to the property owner of 14 Samson Street to have the gravel/stone removed from his front yard and reinstated with 150 mm of topsoil and sodded grass within two weeks of the issuance of the Order.

<u>Discussion:</u> It was noted that this property does not meet the landscaping guidelines and that alternate landscaping requires a plan approved by a landscape architect. With reference to the inquiry as to the number of alternate landscaped front yards – a survey will be undertaken and council advised.

Question called. Motion carried unanimously.

#### 13-06-478 Notice of Motion

<u>Amendment – Mount Pearl Development Regulations 2010</u>

Councillor Aker gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the Mount Pearl Development Regulations 2010, that, if enacted, will:

- 1. In Section 11 Use Zone Schedules, more specifically in the Use Zone Schedules for City Centre (CC), Industrial Light (IL), and Community and Public Service (PB):
  - (a) Under "Permitted Uses", sub-category "Public:", add "Open Air Assembly Use (subject to Regulation 7.20)" in alphabetical order to the list of public permitted uses;
  - (b) where necessary, re-letter existing "<u>Public</u>" permitted uses to accommodate the alphabetical addition as noted above; and
- 2. In Section 11 Use Zone Schedules, more specifically in the Use Zone Schedule for Open Space (OS):
  - (a) under "Permitted Uses", following the sub-category "<u>Recreational</u>:" and prior to the sub-category "<u>Other</u>:", add a new sub-category "<u>Public</u>:", and under that sub-category, add "*Open Air Assembly Use (subject to Regulation 7.20)*".

The purpose of this amendment is to provide Council with the authority to permit outdoor worship services in the land use zones specified above, subject to meeting

the conditions for this type of use as specified in Section 7 – Special Developments, Regulation 7.20 relating to Open Air Assembly Uses.
