12-06-452 <u>Water Conservation Order</u>

Councillor Walsh advised that the latest reports were that the water levels were good and at this point there are no plans to enforce water bans in municipalities and the water conservation policy is still in effect.

12-06-453 Ruth Avenue School District Traffic Study

Councillor Tessier advised that she attended the Traffic Study Public Consultation held on June 18, 2012 which was led by Hatch Mott MacDonald, the City's traffic consultant. She expressed disappointment with the public turnout to this event. It was very well presented by the consultants and it's unfortunate that there were not more attendees to offer their input. It was anticipated that there will be some long-term solutions and short-term fixes as a result of this study.

PUBLIC WORKS COMMITTEE

12-06-456 <u>Automated Garbage Collection (Update)</u>

The roll out of phase 1(a) of the automated garbage collection took place on Friday, June 15 in the Mortimore Drive area. A follow up meeting with residents of the area is scheduled to take place on Thursday, July 5 at City Hall. This will provide residents the opportunity to bring forward concerns or comments on the system.

Phase 1(b) (Farrell Drive, Nash Crescent and Galway Crescent) is scheduled to begin in July with an information session scheduled to take place at City Hall on July 3.

Arrangements are being made to have the carts displayed at City facilities and promotional signage placed in strategic areas of Mount Pearl to promote the use of the new automated system. It is anticipated that the automated garbage collection will be in use by all city residents by year end.

Councillor Stoyles advised that when they did a drive about in the Phase 1(a) areas, she noticed that some of the containers were overflowing. It was noted that there are clear guidelines that the cover is to remain closed so that the automated system can work properly. It was noted that this garbage carts should hold between 4-6 garbage bags.

COMMUNITY SERVICES COMMITTEE REPORT

Residents were encouraged to attend the Legion Memorial Day Ceremonies being held on July 1 at the War Memorial site at Park Place at 11:00 am. The Parade is scheduled to commence at the intersection of Park Avenue and O'Keefe Avenue at 10:30 am.
