14-03-143 Tender – TP-14-004 Turf Maintenance Material

It was clarified that the turf maintenance material (fertilizer, lime and seed) was not associated with the Soccer Field but was to be used throughout the City.

ACTION REPORT

The action report was accepted as presented.

PROCLAMATIONS/PRESENTATIONS

14-03-144 Presentation – NL Housing & Homeless Network

Information was provided on the pancake breakfast fundraiser held by staff in support of the NL Housing & Homeless Network. Kim Mosher, representing City staff, and Sherry Fitzpatrick, representing CUPE Local 2099, presented to David Murphy, NL Housing & Homelessness Network, the amount of \$1,026 from the pancake (ticket sales) fundraiser event, and \$100 from the Mount Pearl Municipal Workers Union – CUPE Local 2099. These proceeds will go to groups fighting homelessness in Newfoundland and Labrador.

14-03-145 Proclamation – "Volunteer Week"

Deputy Mayor Locke signed a proclamation declaring April 6 – 12, 2014 as Volunteer Week in the City of Mount Pearl. Dr. Andrew Furey, Volunteer Week Honourary Chair, provided information on Volunteer Week. Also in attendance were, Jackie Dolomont, Vice Chair, Volunteer Week, VOCM Cares Foundation, Pam Corrigan, Community Sector Council NL and Trish Boyer, School Sports NL.

Council referenced the "Citizen of the Year" event held annually by the Kinsmen Club in conjunction with the City during Volunteer Week to recognize outstanding citizens in our community. (This year's event will be held on April 5, 2014. Further details are available on the City's website.)

14-03-146 <u>Proclamation – Pride Day</u>

Deputy Mayor Locke signed a proclamation declaring March 25, 2014 as Pride Day for O'Donel High, Mount Pearl Senior High, Mount Pearl Intermediate and St. Peter's Junior High. Representatives of the teachers and students of the schools were in attendance and Ms. Donna Rice-Parsons (teacher) spoke on the event and its goal.

14-03-147 Proclamation – World Plumbing Day

Deputy Mayor Locke signed a proclamation declaring March 11, 2014 as World Plumbing Day in the City of Mount Pearl.

John Ozon, President, Canadian Institute of Plumbing & Heating NL Region, was in attendance and spoke on the event's purpose.

14-03-148 Proclamation – Nutrition Month

Deputy Mayor Locke signed a proclamation declaring March 2014 as Nutrition Month in the City of Mount Pearl.

14-03-149 Proclamation – Multiculturalism Week

Deputy Mayor Locke signed a proclamation declaring March 17 - 23, 2014 as Multiculturalism Week in the City of Mount Pearl.

CORRESPONDENCE

14-03-150 <u>Service NL</u>

Information was presented from Service NL in partnership with the Department of Municipal & Intergovernmental Affairs regarding the requirements for land development permitting along protected roads in the province.

The Protected Roads Zoning Regulations, under the Urban and Rural Planning Act, outline the requirements for obtaining a Development Permit to build on or otherwise develop land, whether Crown or privately owned, within the building control lines of a protected roads.

Roads in Mount Pearl include Pitts Memorial Drive and Trans-Canada Highway as it turns into the Outer Ring Road – the portion adjacent to the City. A development within 150 m of the municipal planning area would require two permits - one from the municipality and one from Service NL. The City's practice was clarified whereby applications for principal developments (rather than accessory buildings such as a shed) would be referred to the Service NL for review and permitting. The Province's primary concern is the impact that a major development would have on access points and even signage on the highway system.

14-03-151 <u>MNL Release – Economic Development Accord</u>

A release from Municipalities Newfoundland and Labrador (MNL) was presented announcing a collaborative approach to local economic development. This approach is founded on the concept of cooperation and the sharing of information to better serve municipalities in Newfoundland and Labrador that will help them create and grow jobs within their regions. Its mandate will be to provide an important professional network of economic development professionals to help assess effectiveness and guidance on how to do so. It was noted that a resolution outlining Council's endorsement of this initiative would be presented at an upcoming meeting.

PLANNING AND DEVELOPMENT COMMITTEE

 Proposed Development Regulations 2010 Amendment No. 30, 2014

 11178 Newfoundland Limited
 (Pearlview - Phase 7 Rezoning Amendment)

Motion - Councillor Ledwell/Councillor Aker

RESOLVED THAT the proposed Development Regulations 2010 Amendment No. 30, 2014, (Pearlview Phase 7 Rezoning Amendment), to rezone parcels in the Pearlview Subdivision Extension (Phase 7) consisting of approximately 2.69 hectares (6.64 acres) from RSU-3 to RHD, be adopted as presented and outlined in the Committee reported dated February 4, 2014.

<u>Discussion</u>: The purpose of the amendment is to allow for the development of double dwellings (58 semi-detached dwelling units and one single family unit). This application is a submission on behalf of two property owners, Cardinal Properties and Junction Development.

Councillor Stoyles noted that many of the representations received were similar to those received from neighbouring property owners when one of the applicants attempted to rezone Pearlview Phase 6 from RSU-3 to RMD and as a result, she did not support the amendment.

It was noted that unlike Pearlview Phase 6, which was located between two areas already developed and zoned RSU-3, the area being requested to be rezoned is immediately north of the area that is developed and under construction. The area is currently a green field site. The road network proposed in the rezoning is in accordance with the road network approved for the Kenmount Hill Infill Development Scheme. It was suggested that the proposal will not significantly increase the number of dwelling units in the area. In addition, the developer is attempting to respond to the housing market by constructing a form of affordable

housing that is currently not available in the Mount Pearl market. The increase of 16 units over the current zoning is not viewed as adding significantly to the traffic congestion.

Question called. Motion carried with Councillor Stoyles voting against the motion.

14-03-153 Proposed Mount Pearl Development Regulations 2010 Amendment No. 31, 2014 Add "Self-Service Storage Mall Use" to Use Zones: IL and CM (Self-Service Storage Mall Use Amendment)

Motion - Councillor Ledwell/Councillor Aker

RESOLVED THAT the proposed Mount Pearl Development Regulations 2010 Amendment No. 31, 2014 (Self-Storage Mall Use Amendment) be adopted by Council and submitted to the Department of Municipal Affairs for registration.

<u>Discussion</u>: The purpose of this amendment is to regulate the development of selfservice storage malls in the Commercial – Mixed and Industrial Light use zones in the City.

 Application for Subdivision and Double Dwelling Two Semi-Detached Dwelling Units 50 Jersey Avenue

<u>Motion</u> – Councillor Ledwell/Councillor Aker

RESOLVED THAT approval be granted to issue a development permit for the subdivision of the property at 50 Jersey Avenue to create two (2) lots and construct a Double Dwelling (two semi-detached dwelling units) subject to a building permit not being issued until the building and servicing plans are received and meet the approval of the City.

<u>Discussion</u>: It was noted that the developer has advised that one of the units will definitely be owner occupied; the other unit is not confirmed. The developer has indicated a need for two units to make the project reasonably affordable.

14-03-155 Proposed Site Development (Exterior Storage Yard) WLH Contracting Limited 12 Panther Place

Motion - Councillor Ledwell/Councillor Aker

RESOLVED THAT the development application to undertake site development at 12 Panther Place to accommodate an exterior storage yard for the purpose of temporarily storing scaffolding equipment for a period of 8 months be approved and a development permit issued subject to the following conditions:

- 1. St. John's Regional Fire Department conditions;
- 2. City Inspector's conditions;
- 3. all slopes existing and proposed at 12 Panther Place shall be 2:1;
- 4. any debris shall be removed from 12 Panther Place;
- 5. a buffer at the rear of 12 Panther Place shall be installed, the type of buffer to be determined;
- 6. the manhole on site that has been covered over shall be located and the fill covering it shall be removed then properly re-graded around the manhole;
- 7. Engineering Services conditions; and
- 8. the development meeting Mount Pearl Development Regulations 2010.

Question called. Motion carried unanimously.

14-03-156 Stericycle Waste Transfer Facility Environmental Undertaking – Department of Environment and Conservation 27 Clyde Avenue

Council was advised that, further to previous discussions and consideration of the above-note application, the City has now received a copy of the documentation regarding this environmental undertaking from the Provincial Government Department of Environment and Conservation. This documentation was anticipated as part of the external referral process, the document has been reviewed by staff, and the content is consistent with the application that was previously reviewed by staff and there are no concerns or unanticipated matters.

14-03-158 <u>Notice of Motion</u> Amendment – Mount Pearl Development Regulations 2010

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the land use zoning map of the Mount Pearl Development Regulations 2010 that, if enacted, will:

1. Amend Map 1 – Land Use Zoning Map, as follows:

Rezone the portion of land that is located at the south east corner of Topsail Road and Forsey Place, immediately east of Forsey Place, south of Topsail Road, west of the property at 913-915 Topsail Road, and immediately north of the property at 25 Forsey Place from Residential – High Density – Special (RHD-S) to Commercial Mixed (CM).

The purpose of this amendment is to provide Council with the authority to consider an application for the proposed consolidation of land, the demolition of the existing building and re-development of the property at 913-915 Topsail Road for a car dealership (Tucker Acura). The rezoning of the subject property is for the purpose of extending the Tucker Acura parking lot onto this property.
