PUBLIC WORKS COMMITTEE

12-03-179 Winter Maintenance Update

With the improving weather conditions, crews are beginning the process of cleaning up the City. The street sweeper is deployed during shifts and with weather permitting; the summer vacuum unit (Madvac) will begin cleaning debris from the accessible trails next week.

Night crews have commenced cleaning up debris in commercial areas such as Old Placentia Road. Crews are continually surveying streets for potholes or broken curbs which require repair during daylight hours.

UTM crews have also started our hydrant flushing program which will continue throughout the summer for as long as weather permits.

Council was also advised that staff is researching/compiling data on ways of line painting in order to retain a prolonged presence.

Reference was made to the delay in the reconstruction of the overpass with respect to the same contractor being responsible for that project as well as the Mount Carson Avenue project and whether the delay would impact its completion. The IPW Director was requested to confirm with the contractor that this project remains on schedule.

COMMUNITY SERVICES COMMITTEE REPORT

12-03-180 <u>Services Canada Centre for Youth</u>

Council was advised that as the Federal Government will no longer be funding Service Canada Centres for Youth. The services handled by the seasonal office will continue through existing Service Canada offices and online year round. It was confirmed that computer services were available at the Ross King Memorial Public Library. It was agreed that Mayor Simms would forward a letter to the Prime Minister expressing Council's disappointment with this action.

12-03-181 Correspondence - Vera Perlin Society

Council was advised of a letter of appreciation from the Vera Perlin Society, thanking the Reid Community Centre staff for their support in relation to their performance during Frosty Festival.

12-03-182 Glacier Arena

12-03-190 107 Smallwood Drive – Quote To Remove Hazardous Materials

RESOLVED THAT approval be granted to award the quotation for the removal of hazmat material from 107 Smallwood Drive to the lowest bidder, Power Vac Services, in the amount of \$11,500 (plus HST).

<u>Discussion:</u> It was noted that this property was acquired by Council for the purpose of upgrading Arena Road. Power Vac Services has confirmed that the scope of work will include the removal of all material (in accordance with the Pinchen Leblanc report) and draining the oil tank. The City will be required to provide a water supply which will be required for the decontamination process.
