10-05-351 Bulk Garbage Collection

Council referenced the guidelines for bulk garbage collection, noting that "construction materials" will not be collected – as identified in the bulk collection brochure delivered to all households. Council commented on the uncertainty among residents as to what will be collected and suggested that a second notification be forwarded to residents clearly articulating items that will be collected, and likewise not collected. It was requested that the matter be referred to the Public Works Committee with consideration being given to the collection of home renovation materials. In the meantime, residents were reminded that construction materials will not be collected, metals should be separated, and items should not spill over into the street.

10-05-370 <u>Mount Carson Upgrading and Realignment</u> Expropriation of Land Required by the City

<u>Motion</u> – Deputy Mayor Locke/Councillor Aker

RESOLVED THAT the following be taken in relation to the lands required to carry out the upgrading and realignment of Mount Carson Avenue:

- approval be granted to release the City's funds of \$42,500.00 for the purchase of subject lands by the City from Group Holdings Limited;
- approval be granted to proceed with the processing of legal documents to execute the land exchanges with the property owners who have provided agreement in writing, CDD Holdings Ltd. and the St. John's Christadelphians. Pending successful execution of the land exchanges, it

is further recommended that the expropriation process be discontinued in relation to these two properties; and

 approval be granted to continue communication with the property owner, 11244 Newfoundland Ltd., to secure written confirmation of the verbal agreement and then execution of same regarding the land exchange; and, pending this confirmation and successful execution of the land exchange, that the expropriation process be discontinued in relation to this property.

<u>Discussion:</u> Council was advised that a portion of the road work will be undertaken this year in preparation of creating a thoroughfare from Mount Carson Avenue directly to Kenmount Road. It is anticipated that this reconfiguration will alleviate the current traffic congestion.

Amendment – Mount Pearl Development Regulations 1988

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will:

"rezone the portions of the lands within 1246-1260 Topsail Road that are currently zoned Industrial-Light (LI), from Industrial-Light (LI) to Mixed Development (MD). "

The intention of this amendment is to accommodate an extension to the west of the building defined as 1256 Topsail Road, and to rectify the designation and zoning boundaries to correspond to property ownership of 1246-1260 Topsail Road. This amendment is brought forward by the property owner of 1246-1260 Topsail Road.

10-05-374 <u>Development Permits</u>

Motion - Deputy Mayor Locke/Councillor Aker

RESOLVED THAT development permits issued for the period of May 8 - 14, 2010 be approved as presented.

<u>Discussion:</u> Reference was made to the development permit issued for 1 Olympic Drive (former Pearlgate Lanes). It was noted that the permit was issued in accordance with the City's regulations. Council recognized the significance of maintaining the bowling alley and held meetings with the new owners; however, it was a private business transaction. It was acknowledged that the new owner did maintain ten lanes.

10-05-376 Focus on Youth Awards

Members of Council individually expressed congratulations to the Focus on Youth Awards nominees and winners as well as to staff and sponsors.

10-05-377 <u>O'Donel Senior High</u> Mount Pearl Senior High

Councillor Tessier extended congratulations to the Level III students on the occasion of their Senior Prom. Appreciation was also extended to staff and volunteers who help make it a special event.

10-05-378 NF Christian Riders

Councillor Tessier advised of a breakfast organized by the NF Christian Riders being held on May 29 at the Salvation Army Citadel, Ashford Drive, to raise funds in support of prostate cancer research ("Big Ride").

10-05-379 Garbage Nets

Councillor Lane advised of a couple of incidents whereby residents were charged a \$45 fine as a result of garbage being torn open even though it was covered by a net. The Director of Infrastructure & Public Works advised that the service charges reflect costs associated with having staff clean up the waste. He further advised that if it was evident that the garbage had been covered, these charges could be reversed. Councillor Lane requested the matter be referred to the Public Works Committee for further consideration and subsequent report to Council.

10-05-380 Dirt Bikes, ATV's

Councillor Lane reminded residents that it was illegal to operate dirt bikes, ATV's within City boundaries and when caught, drivers are subject to fine and impounding fee.

10-05-381 Chief of Police – Royal Newfoundland Constabulary

Councillor Lane requested that a letter of congratulations be forwarded from the Mayor's office to the new Chief of Police, Robert Johnson.

10-05-382 <u>Municipal Awareness Day</u>

Councillor Lane noted that May 20th is Municipal Awareness Day and extended appreciation to all staff.

10-05-383 <u>City of Calgary</u>

Councillor Lane presented a publication from the City of Calgary that outlined common issues by residents and how these issues can be addressed. He referred it to the Public Works Committee for consideration on implementing a similar brochure for the City of Mount Pearl.

Councillor Stoyles presented the year-end report for the Airport Authority, noting that while the rest of Canada experienced an average 6% decline in passenger traffic in 2009, the number of travelers flying in and out of St. John's increased by almost 1%.
