# 14-05-301 Mount Pearl Adult Materials Display Regulations

**Background** 

The City's solicitor has advised that it is not mandatory for the City to pass regulations relating to the display of adult materials. The City's solicitor further advised that the matter of materials that are deemed to be "obscene" are addressed adequately within the Criminal Code of Canada.

# 14-05-303 <u>Proposed Accessory Building</u> <u>Flanking Street Side Yard – Corner Lot</u> 116 Farrell Drive

RESOLVED THAT an application for a proposed accessory building in the flanking street side yard of a corner lot at 116 Farrell Drive be approved and a conditional development permit be issued.

#### 14-05-304 Notice of Motion

Amendment – Mount Pearl Development Regulations 2010

Councillor Ledwell gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy,

he will, at a regular meeting of Council, move an amendment to the Land use Zoning Map of the Mount Pearl Development Regulations 2010 that, if enacted, will:

- 1. Amend Map 1 Land Use Zoning Map, as follows:
  - rezone a 2.0 x 84.0 m portion of land that is located on the east side of Lot Numbers 44 - 38 on Pollux Drive, Moffat Road Subdivision, Phase 4 from Open Space (OS) to Residential Single Family Detached (RSU-3)
  - rezone a 4.9 m<sup>2</sup> portion of land that is located on the east side of Lot Number 37 on Pollux Drive, Moffat Road Subdivision, Phase 4 from Open Space (OS) to Residential Single Family Detached (RSU-3)
  - rezone a 4.28 x 50.91 m portion of land that is located east of Lot Numbers 44 41 on Pollux Drive, Moffat Road Subdivision, Phase 4 from Open Space (OS) to Commercial Mixed (CM).

The purpose of this amendment is to provide Council with the authority to consider an application for the proposed development of Phase 4 of the Moffat Road Subdivision. The redesignation and rezoning of the subject property is for the purpose of enlarging proposed building lots to consistent sizes and to convert a remnant area zoned Open Space to s functional use (i.e., Commercial – Mixed).
