SAFETY MESSAGE

15-11-749 Safety Message

Councillor Aker reminded residents that the "move over" law came into effect in March 2014 and is designed to protect those who drive emergency and other designated vehicles such as our municipal enforcement and public utility and service vehicles. The law requires drivers to slow down and move over when approaching a designated vehicle that is stopped in a lane or on the edge/ shoulder of a road. The general rule is to create a buffer lane by slowing down and putting as much distance as possible between you and the stopped vehicle.

COMMITTEE REPORTS

PLANNING AND DEVELOPMENT COMMITTEE

15-11-751 <u>Proposed Municipal Plan and Development Regulations Amendment</u> (16-24 Glendale Avenue)

Background

The City is in receipt of an application dated November 26, 2014 from LAT49 on behalf of Gibraltar Development Ltd. to amend the Mount Pearl Municipal Plan and Development Regulations to accommodate a proposal to redevelop property for the purposes of constructing a condominium apartment building at 16 - 24 Glendale Avenue.

The applicant is requesting that the property be re-designated from RURAL and GENERAL COMMERCIAL to RESIDENTIAL and rezoned from Rural, Commercial-General and Residential - Medium Density (RMD) to Residential - High Density (RHD) to accommodate a 3 to 4 storeys 60 unit condominium apartment development.

Due to the nature of the proposal and to provide sufficient public information on this proposal, a Land Use Impact Assessment (LUIA) was required of the developer. The LUIA has been available on the City's website since June 10, 2015.

As a result of the issues raised at the briefing session, Council proceeded with the following studies in an effort to address these concerns:

- Land Use Impact Assessment Report
- Height and Viewscapes Study
- Value Impact and Analysis Study
- Analysis of Existing Infrastructure

These studies are available on the City's website. Council now has the information required to make a decision on the amendment.

Motion - Councillor Walsh/Councillor Ledwell

RESOLVED THAT the Mount Pearl Municipal Plan 2010 Amendment No. 15, 2015 and the Mount Pearl Development Regulations 2010 Amendment No. 48, 2015 (16-24 Glendale Avenue Amendment) be adopted by Council AND FURTHER THAT Stan Clinton be appointed Commissioner for the public hearing scheduled for December 10, 2015.

<u>Discussion:</u> Council supported the proposed amendment to allow the authority to consider a future proposal for a 3-4 storey 60 unit residential condominium apartment building at 16–24 Glendale Avenue. The proposed amendment would allow Council to consider the apartment development proposal and that the

current infrastructure and road network in the area can support the proposed redevelopment of the site. Members of council believe the proposal would be a positive addition to the City's housing. The process to notify members of the public of the upcoming hearing was clarified. Approval of the amendment allows the process to move forward to the next level of consultation.

An update on watermain repairs/replacement on Commonwealth Avenue and Maple Street was provided. It was noted that the watermain repair on Maple Street was associated with the ongoing construction project. The benefit of using the citizen alert advising residents of the road closure (Commonwealth Avenue – Southbound – at the intersection of Ruth/Park Avenue) was acknowledged. Appreciation was extended to staff for their efforts in carrying out the repairs as quickly as possible. It was noted that protocol is being reviewed with respect to addressing the significant number of calls that were received regarding the break (loss of water).

A winter maintenance report will be provided regularly when conditions warrant.
