PUBLIC WORKS COMMITTEE REPORT

12-10-710 Automated Garbage Collection (Update)

Garbage cart delivery is ongoing with approximately one-half completed to date. The following points were made:

- Carts are to be used immediately upon receipt. Household garbage will only be collected if it is contained in a City cart.
- Residents requesting the "opt out" option for subsidiary apartments that are not currently rented should forward their request (for one cart only) to the attention of the Infrastructure & Public Works (IPW) Department.
- Consideration is being given to requests from property owners who only require one cart even if their subsidiary apartment is rented. At this time, properties with two units will receive two carts. Residents should forward their request (for one cart only) to the attention of the IPW Department.
- The City is also considering ways to accommodate seniors and other residents who have extenuating circumstances with respect to getting the carts to the curb.
- The IPW Department is addressing complaints, issues, challenges and concerns as they arise.
- It was noted that there is technology available to determine if a cart was, indeed, emptied. Consideration is being given to implementing this option.

12-10-722 Proposed New Building (Third Building on Lot) and Associated Site Development DEL Contracting Limited (Protek Industries Limited) – DA12-00591 Proposed Self Storage Mall 41 Sagona Avenue

RESOLVED THAT the application by Del Contracting Limited, on behalf of the owner Protek Industries Limited, to construct an approximate 746 m² building at 41 Sagona Avenue, as a third building on the site which is proposed to be a Self Service Storage Mall Use be approved and a development permit issued subject to the following conditions:

1. St. John's Regional Fire Department conditions

- 2. Newfoundland Power conditions
- 3. City Inspector conditions
- 4. Planning Services conditions
- 5. Engineering Services conditions
- 6. Signing of a development agreement for three buildings on one lot
- 7. Development meeting Mount Pearl Development Regulations 2010

<u>Discussion</u>: It was noted that this particular application is an anomaly and Council is not proposing to move forward with the placement of second and third buildings on existing sites.
