RESOLVED THAT approval be granted to award the tender for the Sunrise Avenue Drainage Basin Project to the lowest qualified bidder, Modern Paving, in the amount of \$456,332.42.

# PLANNING AND LAND USE DEVELOPMENT COMMITTEE

10-10-772 <u>Purchase of Land for Buffer</u> East Port Properties Limited

Motion - Councillor Aker/Councillor Tessier

RESOLVED THAT approval be granted to purchase 0.433 hectares (1.07 acres) of East Port Property Limited lands in the amount of \$107,000.00.

<u>Discussion</u>: This land is required as part of a larger open space buffer and linear park between the Moffatt Road residential development and the Beclin Business Park – both of which are currently under development.

It was clarified that this land is in addition to the 20m buffer being provided by the developer and is being purchased by the City in recognition of the problems experienced by the residential property owners in an effort to reduce the disruption to the neighbourhood.

# 10-10-775 Notice of Motion

Amendment – Mount Pearl Development Regulations 1988

Councillor Aker gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988, and in accordance with Council's public notification policy, he will, at a regular meeting of council move an amendment to the Mount Pearl Development Regulations 1988 that, if enacted, will amend *Part II – General Development Standards* as follows:

- 1. Clarify the regulations numbering references to be consistent with numbering in the Development Regulations;
- 2. In Regulation 35, Antenna, delete Regulation 35(3)(d): and,
- 3. In Regulation 40, Height Exceptions, delete the reference to "20%" and replace with "25%".

The intention of this amendment is to make the Development Regulations consistent with the federal Radio Communication Act with respect to the placement and location of an antenna.

### 10-10-780 Newfoundland Power – takeCHARGE of Your Town Challenge

Councillor Stoyles commented on the City's participation in the energy efficiency challenge for municipalities, launched at the MNL Convention by NF Power and NL Hydro. Municipalities and local service districts will have between October 7 – 31, 2010 to register for the Challenge. The municipality that reduces their energy consumption by the highest percentage (compared to same period in 2009) will win a \$10,000 energy efficient upgrade/retrofit for a municipality facility in their own town/city.
