PLANNING AND LAND USE DEVELOPMENT COMMITTEE

12-10-688 Proposed Mount Pearl Development Regulations Amendment No. 9, 2012 <u>Mobility Impaired Parking Spaces Amendment – 103-5-235</u> <u>Consistency of Development Regulations with Government Legislation</u>

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT approval be granted to adopt the Mount Pearl Development Regulations Amendment No. 9, 2012 (Mobility Impaired Parking Spaces Amendment) as follows:

1. Amend Section 2- Definitions, by adding the following definition in the list of definitions:

"Designated Mobility Impaired Parking Space" means a parking space designated for motor vehicles used by persons with a mobility impairment."

2. Amend Section 9 — Off-Street Parking and Loading Regulations, by adding the following section after Section 9.3:

9.4 Designated Mobility Impaired Parking Spaces

For any development where parking spaces for person with disabilities, are required pursuant to the Building Accessibilities Regulations under the Building Accessibility Act (Newfoundland and Labrador), such spaces shall be provided on the basis of one (1) parking space per lot or four percent (4%) of the total number of required parking spaces provided on the lot, whichever is greater, and such parking space or spaces shall be designated and marked in accordance with the Designated Mobility

Impaired Parking Regulations under the Highway Traffic Act (Newfoundland and Labrador) and the Building Accessibilities Act.

12-10-689 <u>Seaboard Liquid Carrier Limited</u> <u>Proposed Discretionary Use – DA12-00677</u> <u>Above-Ground Diesel Storage Tank – 31 Allston Street</u>

<u>Motion</u> – Councillor Aker/Councillor Ledwell

RESOLVED THAT a development application to install an above ground storage tank for diesel fuel with 75,000 litre capacity and associated dispensing unit in rear of the existing building at 31 Allston Street be approved and a development permit issued subject to the following:

- 1. Mount Pearl Development Regulations
- 2. City Inspector's commentary
- 3. St. John's Regional Fire Department requirements
- 4. Government Services Centre requirements
- 5. Pollution Prevention Division requirements
- 6. Submission of emergency / spill response plan

12-10-690 <u>Notice of Motion</u> Amendment – Mount Pearl Development Regulations 2010

Councillor Aker gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he will, at a regular meeting of Council, move an amendment to the text of the Mount Pearl Development Regulations 2010 that, if enacted, will:

Address a number of anomalies within the Development Regulation with respect to reflecting the amendments to the Development Regulations, and to correct typographic errors and numerical references within the regulations.

The purpose of the proposed amendment is to clarify a number of matters within the regulations that are not substantive changes to the main body the regulations but are deemed as housekeeping amendments with respect to grammar, reference to sections, correction to zoning symbols and identification of amended sections within the development regulations.

12-10-691 <u>Development Permits</u>

ENGINEERING SERVICES COMMITTEE

12-10-693 Update of Multiplex

Council was provided with an update on the status of the Multiplex project advising that at the end of September the project was approximately 18% complete.

Mayor Simms advised that a request was made to the Corporate Services Department (IT Manager) to check out the possibility of having a web cam erected on site, so that the project can be viewed by the public throughout the construction process.

NEW BUSINESS

12-10-694 Dinner Theatre – Church of the Good Sheppard

Councillor Stoyles advised of a Dinner Theatre and dance, sponsored by the Church of the Good Sheppard, taking place at the Reid Community Centre on October 13, 2012 at 7:00. Tickets are \$50 each and dinner entertainment will be performed by Amy House and dance music by Dave Lewis.

12-10-695 Development at Parkdale Ridge

Councillor Walsh advised that he had a call from a resident of Avery Place inquiring about the status on the development in the area. The Director of Planning and Development advised a meeting was held recently with the developers and there were a number of outstanding matters to be addressed. It was noted that building permits will be issued for the next phase next week. Construction will continue for the next while but a timeframe of when the construction will be completed cannot be determined at this time.

12-10-696 Access to Team Gushue Bypass Road

Councillor Walsh advised that a resident inquired whether there would be an access to the Team Gushue Bypass Road from Avery Place and the Director of Planning and Development advised that there will be no access. Councillor Walsh requested a copy of a map for this area.

12-10-697 Gas Prices in Mount Pearl vs. St. John's

Councillor Walsh advised that he received a phone call from a resident of Mount Pearl who was concerned about possible gouging at the gas stations in Mount Pearl. The resident advised that gas was selling by as much as 4.9 cents higher in Mount Pearl at some stations in St. John's and when he approached one Mount Pearl gas station owner about the difference, the owner advised that it was market driven. He then noted that other gas stations in Mount Pearl were charging the same price for gas but within minutes of being approached their prices had be adjusted to 4.9 cents lower.

12-10-698 Northeast Avalon Regional Economic Development Board

Councillor Ledwell updated Council on the progress of the Northeast Avalon Regional Economic Development Board since their loss of funding from the Provincial and Federal governments. They are proceeding with activities and are holding a municipal consultation session at the Comfort Inn on October 24th from 5 to 9 p.m. and invited all Council to attend.

12-10-699 Compliments to Staff

Deputy Mayor Locke advised that he received a lot of compliments from residents regarding the great and expeditious job that the staff of the Infrastructure and Public Works Department did on the cleaning up of the debris from Hurricane Leslie. The Director of Infrastructure and Public Works was asked to relay the message to all staff.

12-10-700 Employee Recognition Awards Night

Deputy Mayor Locke expressed appreciation to the organizing committee of the Employee Recognition Awards Night. It was a great night with great entertainment and also congratulations to all of the award recipients.

12-10-701 Blue Zone Parking

Councillor Tessier reminded residents to respect the blue zone parking areas.

12-10-702 Flower Pots

Councillor Tessier advised that she has received many compliments on the flower pots placed around the City this year and how they enhanced the beauty of the

City. Because of the beautiful weather, the flowers are continuing to be maintained and are still in bloom, which is very unusual for this time of year in Mount Pearl.

12-10-703 Open House - Condominiums - Park Avenue

Councillor Aker advised that he attended an open house last night regarding the proposed condominium apartment buildings for 166 Park Avenue. There were a lot of good comments made in relation to this proposal. This issue will be brought to the next Committee meeting for further discussion.

12-10-704 Soccer Team

Councillor Aker advised that three soccer teams (Under 16) are participating in a national tournament and wished them well.

12-10-705 <u>CBC Radio</u>

Councillor Aker advised that there will be a Planning Officials panel on the CBC Morning Show on Friday, October 5th and the Director of Planning and Development, Stephen Jewczyk, will be participating.

12-10-706 <u>Seniors Independence – Afternoon Tea</u>

Councillor Stoyles reminded Council of the Seniors Independence Afternoon Tea taking place tomorrow afternoon. Councillor Stoyles will be out of town and sends her regrets to the group.
