12-09-615 <u>Demolition of Existing Dwelling and New Single Detached Dwelling – DA12-00617</u> 115 Commonwealth Avenue

Motion – Councillor Aker/Councillor Ledwell

RESOLVED THAT the development application to demolish the existing dwelling and construct a new single detached dwelling at 115 Commonwealth Avenue be refused for the following reasons:

- The proposal to replace the existing non conforming use with a new non conforming use is in conflict with the Urban and Rural Planning Act, 2000 Part XII Non-Conforming Use, Newfoundland Regulation 2001, Development Regulations under the Urban and Rural Planning Act, 2000 Section 14, Residential Non Conformity.
- 2. The development proposal is contrary to the General Commercial land use polices of the Mount Pearl Municipal Plan 2010.
- 3. The development proposal is contrary to the Mount Pearl Development Regulations and more specifically is not a permitted or discretionary use within the Commercial-General (CG) Use Zone.

12-09-624 <u>Automated Garbage Collection</u>

Deputy Mayor Locke noted that the automated garbage collection system will provide a safer environment for the City's operators, i.e. decrease in injuries due to garbage being improperly bagged.
