PLANNING AND DEVELOPMENT COMMITTEE

14-09-600 **Karwood Contracting**

Proposed Condominium Apartment Building

166 Park Avenue

Motion – Councillor Ledwell/Councillor Walsh

RESOLVED THAT an application for the three-storey, 48-unit condominium apartment building at 166 Park Avenue be approved and a development permit be issued subject to the requirements of all external authorities and the City.

Discussion: It was acknowledged that there is a storm and sewer surcharge issue in the immediate area which the City is in the process of addressing. As an interim

measure, the development may require some form of on-site treatment until the sanitary sewer capacity issues are addressed. The proponent has indicated that should municipal services not be available, temporary on site treatment can be provided until such time as services are upgraded.

14-09-601 <u>Hennebury Engineering (NF Marine Safety Systems)</u>
Building Extension – Update of Existing Joint Access Agreement
8 Kyle Avenue

Motion - Councillor Ledwell/Councillor Walsh

RESOLVED THAT a development permit be issued to Hennebury Engineering (on behalf of NF Marine Safety Systems) to construct a building extension with a floor area of 335 m² (3606 sq. ft.) to the west (rear) elevation of the existing building at 8 Kyle Avenue to accommodate a Light Industry (workshop) Use subject to the following conditions:

- 1. submission of a revised site plan illustrating landscaping, paving and curbing to the rear wall of the proposed building extension, and all other items previously requested as per the Site and Services Bulletin;
- 2. in the revised plans, the applicant to provide information as required by the Engineering Services Division for their review and approval prior to the issuance of a building permit;
- 3. the joint access agreement to be revised to reflect the tractor trailer turnaround movement on the abutting property;
- 4. submission of a completed Landscaping Cost Estimate form for approval; the refundable landscaping deposit is required to be submitted based on the approved estimated cost of landscaping;
- 5. the proposal is required to meet all Regional Fire Department requirements; this commentary to be received by the City and copied to applicant prior to the issuance of any Building Permits;
- 6. City Inspector's conditions; and
- 7. the development meeting Mount Pearl Development Regulations 2010.

Question called. Motion carried unanimously.

14-09-602 <u>Proposed Mount Pearl Development Regulations 2010 Amendment No. 40, 2014</u> <u>Changeable Message Sign Amendment</u>

Motion – Councillor Ledwell/Councillor Walsh

RESOLVED THAT the Mount Pearl Development Regulations 2010 Amendment No. 40, 2014 be adopted and submitted to the Department of Municipal and Intergovernmental Affairs for registration.

<u>Discussion:</u> The purpose of the amendment is to regulate the brightness of changeable message signs in order to minimize, especially at night: distractions to drivers, safety hazards, nuisance to residents, and negative effects on the look, character, and quality of areas visible to the public. Property owners for existing signs would be advised of the new requirements, and some of these signs already have the technology to make minor adjustments to comply with the proposed new requirements. Signs not easily adjusted to comply with the new requirements but were installed with a permit and met the regulations at that time would be permitted to remain in place unless there was a complaint or a safety concern.

Question called. Motion carried with Councillor Stoyles abstaining from voting due to a potential conflict of interest.

REGIONAL SERVICES & ENVIRONMENT COMMITTEE

14-09-606 <u>TD Canada Bank – Hosted by Conservation Corps NL (CCNL)</u> Tree Planting Initiative – Sunday, September 21, 2014

The public was advised of a tree planting initiative - TD Tree Days that provides TD employees, their families and friends, and members of the community the opportunity to volunteer in the communities where they live and work, and to demonstrate their commitment to forest stewardship. The event will be coordinated by the Conservation Corps and with the City's assistance, held on Sunday, September 21, 2014 starting at 9:00 AM – rain or shine! The site selected is the Mount Carson Terrace Phase 4 detention pond area and Donovan Homes will provide \$6,000 towards the event representing their commitment to the development.

14-09-607 Water Levels – Bay Bulls Big Pond

The most recent report shows that the water level at Bay Bulls Big Pond is increasing, however, even with all the rain, water levels are not rebounding quickly. Discussion ensued regarding the level of demand on Bay Bulls Big Pond and it was requested that data in terms of consumption be obtained.

TRANSPORTATION & PUBLIC SAFETY COMMITTEE

14-09-608 Running Event (Huffin Puffin Road Race) – September 21, 2014

The public was advised of a running event to be held on September 21, 2014 (start time 7:30 AM) in accordance with the route presented. Representatives with St. John Ambulance, the Royal Newfoundland Constabulary and the City's Municipal Enforcement Division will provide assistance.

14-09-609 <u>School Zone</u> Safety Checks

The public was advised that the City's Municipal Enforcement Division and the Royal Newfoundland Constabulary will be conducting school zone safety checks (commenced September 8) targeting speeders in and around the school zones.

NEW BUSINESS

14-09-610 Speeding Vehicles

Deputy Mayor Locke commented on the perception that a significant number of drivers travel faster than the posted speed limit. He requested that data on speeds be compiled and provided to Council.

14-09-611 <u>Sidewalks – Smallwood Drive</u>

Deputy Mayor Locke noted that the sidewalk along sections of Smallwood Drive is considerably cracked and questioned the life cycle and whether the use of the large snowblowers caused some of the damage. It was indicated that sidewalks should last 20 - 30 years if a proper inspection and a good design were undertaken at the time of installation. In the meantime, this sidewalk has been identified for repairs and will be included in the 2015 budget submission for consideration by Council.

14-09-612 <u>Dog Park</u>

Deputy Mayor Locke advised of a request for a modification under the gate to the small dog section of the park to prevent small dogs from digging under the gate and getting out. Referred to staff for review.

Mayor Simms further requested consideration be given to maintaining the dog park during the winter months.

14-09-613 Renaming – Upper Smallwood Soccer Field

Members of council spoke of the renaming of the Upper Smallwood Soccer Field to the Ed Moyst Soccer Field in recognition of Mr. Moyst's contribution to the introduction and continuation of soccer, as well as other sports, in Mount Pearl.

14-09-614 Northeast Avalon Joint Council (NEAJC)

Councillor Stoyles advised that the meetings of the NEAJC would be resuming starting September 17 in the Town of Torbay.

14-09-615 Out of the Box Art Program

Councillor Stoyles noted that the painting of the traffic boxes has commenced and are very well done. Anyone interested in painting a box is asked to contact the Community Services Department (Garry Fraser) for further information.

14-09-616 Condolences – Bridie Lawlor

Councillor Stoyles extended condolences to the family of Bridie Lawlor who was a long time resident of Mount Pearl.

14-09-617 Dodge City – Fence

Councillor Walsh advised of a complaint regarding the condition of the fence on the Dodge City property. Issue referred to staff for follow up.

14-09-618 <u>Stopping for Emergency Vehicles</u>

Councillor Tessier reminded residents that it is the law to yield to emergency vehicles.

14-09-619 Traffic Lights

Councillor Aker requested that the traffic lights at Richard Nolan Drive/Old Placentia Road as well as Richard Nolan Drive/Commonwealth Avenue be checked with respect to their sequence. Referred to staff for follow up.

14-09-620 Mount Pearl-Paradise Chamber of Commerce

Councillor Ledwell advised that the Chamber will be holding a Business Expo on September 24 at the Reid Community Centre. Approximately 36 businesses have registered and he encouraged others to register as well.

14-09-621 <u>Federation of Canadian Municipalities (FCM) – Board Meeting</u>

Mayor Simms provided an update of the FCM Board meeting noting that agenda items included discussions on investing in Canada's home towns, affordable housing and funding for research and implementation of new wastewater technologies. Further information will be tabled as it becomes available.

14-09-622 Racing with the Reverend – Announcement & Celebration

Mayor Simms advised that Reverend David Burrows and his team will be holding an event on Wednesday, September 10, 2014, (starting at 3:00 pm) at St. David's field. He noted that representatives from the Icecaps/Williams Family Foundation will be making a donation. The overall event is to raise awareness and funding for the Autism Society NL.

14-09-623 Urban Municipalities Committee (UMC)

Mayor Simms advised that the UMC will be meeting September 12 - 13 in St. John's and discussions will include the continuation of their collaborative approach to local economic development.

14-09-624 Citizen ALERT Program

Mayor Simms commented on the Citizen ALERT program launched today's date and encouraged everyone to sign up. This system will give immediate and advanced warning of emergency situations and service interruptions affecting the City of Mount Pearl.
