For the information of public, the Law Enforcement Torch Run takes place on June 15th and a stop includes the H. Neil Windsor Municipal Building (City depot) at approximately 12:00 noon.

18-06-414 <u>Old Placentia Road Closures</u> Street Jam Hockey – June 22 - 24

For the information of the public, the Street Jam Hockey Tournament takes place on Old Placentia Road from June 22 to June 24. As a result, the street will be closed to vehicular traffic during this time.

Discussion:

Councillor Stoyles noted that she was not against the tournament but she didn't support the closure of a portion of Old Placentia Road. She suggested that the parking lot at the Senior High/Intermediate Schools would work just as well. She recognized that the tournament was proceeding and as such, requested that the event be communicated with area residents, businesses and organizations, and every effort be made to minimize any resulting problems.

Other members of Council supported the event noting that the overall benefits of the tournament (i.e. economic, sports tourism, and children being active) outweigh any inconveniences. It was indicated that the condition of the pavement on the school parking lot was not conducive for street hockey. It was noted that the intersections on Commonwealth Avenue will be open. It was confirmed that a communication plan is in place and further that this year's event is on a smaller scale which may mean not as many parking issues.

INFRASTRUCTURE AND PUBLIC WORKS COMMITTEE

18-06-416 <u>Change Order – CBCL Design Support</u> Roosevelt Avenue, Roland Drive, St. Andrew's Avenue

RESOLVED THAT approval be granted to apply under the FCM's Municipal Asset Management Program for an Holistic Asset Management Planning Development project, in the amount of \$71,875.00 (HST included).

Project

- Analysis of existing infrastructure nature, format and flow
- Creation of infrastructure modeling parameters
- Forecasting of infrastructure needs and performance

The City commits the lesser of \$15,179 or 21% from its budget towards the total costs of this initiative per FCM guidelines for funding.

18-06-420 <u>Spring/Summer Maintenance Updates</u>

An update on public works maintenance activities was provided. Residents were reminded that during June, July and August, a maximum of two bulk collections can be requested free of charge.

18-06-421 Clothing Bins – Canadian Diabetes Association

For the information of the public, the City has commenced a pilot project (for a period of one year) with the Canadian Diabetes Association for the placement of clothing bins at the following City facilities:

- H. Neil Windsor Municipal Building
- Summit Centre/Glacier (2 locations)
- Gloria Pearson Community Centre
- Team Gushue Arena Road (area of mailboxes)

Councillor Stoyles acknowledged that the collection of clothing is worthwhile, however, she expressed concern with users who choose to leave their items outside the bins when they're full.

Other members of Council noted that it is a one-year pilot project which the City can withdraw from at any time. Users were encouraged to seek an alternate bin if one is full and be aware that the bins are for clothing only.

The suggestion to utilize cameras to prevent the overflow was referred to the IPW Committee for review and analysis.

18-06-422 <u>Application for Variance re Accessory Building Size – DA18-0234</u> 78 Fourth Street

18-06-429 Community Food Drive

Members of Council encouraged residents to support the upcoming food drive scheduled for June 16th. Volunteers will gather at St. David's Park and be going door-to-door seeking donations; bins will be set up in the local supermarkets. It was noted that volunteers will also be needed at each of the food banks (St. Peter's and Mary Queen of the World churches) to sort the collected items.

18-06-430 Public Service Work

In recognition of Public Service Week, members of Council extended appreciation to all staff for their hard work and dedication in providing municipal services and programs.

18-06-431 Seniors Independence Group

Councillor Stoyles advised that the Seniors Independence Group will be offering a "mowing service" for seniors unable to mow their lawns; contact their office for further information.

18-06-432 <u>Condolences – Wicks</u>

Councillor Stoyles extended sympathy to the family and friends of Lloyd Wicks. She noted that Mr. Wicks was the first chairperson of the Waste Management Committee (now Eastern Regional Service Board).

18-06-435 Newfoundland Hockey Hall of Fame

Councillor Stoyles extended congratulations to resident Jim Heale who was recently inducted into the Newfoundland Hockey Hall of Fame.

18-06-436 Canada Post

Councillor Stoyles advised that a contractor for Canada Post has been parking on the area surrounding the community mailboxes while removing graffiti. Referred to the Infrastructure & Public Works Department for follow up. Appreciation was extended to Canada Post for addressing issues raised by Council on behalf of residents.

18-06-437 FCM Conference

Councillor Ledwell commented on his attendance at the FCM Conference and provided a brief update on issues discussed.
