18-06-465 Request for Proposal (RFP)

Owners Project Manager (OPM) Services for 2018 Street Upgrading

Motion - Councillor Fry/Deputy Mayor Locke

RESOLVED THAT approval be granted to award the RFP for the OPM Services for the 2018 street upgrading project to Vigilant Management in the amount of \$473,944.30 (HST included).

Note: The project will be divided into four packages:

- Package 1 Glendale Avenue and Bradley Place
- Package 2 Fourth Street & St. David's Avenue
- Package 3 Roosevelt Avenue, Roland Drive and St. Andrew's Avenue
- Package 4 Donovan's Business Park Improvements Phase 2

<u>Discussion:</u> It was noted that there were multiple bids received, these were assessed, and discussions were held with the proponents, which resulted in the preceding recommendation. It was indicated that the City has prior experience with the consultant as they had undertaken projects related to the Kenmount Hill infrastructure planning.

18-06-467 <u>Application for Variance re Minimum Frontage and Minimum Lot Area</u> 18 Valleyview Avenue

RESOLVED THAT a development application to subdivide 18 Valleyview Avenue to create two residential lots, requiring a 5.75% (15m to 14.14m) variance to the minimum frontage and a 4.25% (450 m² to 430.88 m²) variance to the minimum lot size, be approved subject to the following conditions:

- 1. meeting the requirement/conditions of:
 - Finance Services Division,
 - City Inspection Services,
 - Planning and Development Department,
 - Mount Pearl Building Regulations,
 - Mount Pearl Development Regulations 2010; and
- 2. meeting the *National Building Code* 2015 Edition and ancillary codes.

18-06-468 Order – 13-17 Commonwealth Avenue (Domino's Pizza)

Act, 2000, the Mount Pearl Development Regulations 2010, and the Mount Pearl Building Regulations 2011.

<u>Discussion:</u> It was indicated that prior to issuing the Order, staff had worked on the file for over six months; there were frequent visits to the property. Since then there has been progress to address the outstanding issues and it is hopeful, subject to work continuing, an occupancy permit may be issued in 7-10 days. The file/property will continue to be monitored by staff.
