## 18-07-527 New Collective Agreement with CUPE Local 2099

#### Background:

It was noted that the City's collective agreements with its unionized employees represented by CUPE Local 2099 and CUPE Local 2099-1 expired on June 30, 2018. A tentative agreement was reached on June 28, 2018 after discussions with Council and CUPE ratified the agreement on July 10, 2018.

The agreement resulted in a merge of the two collective agreements into one and it covers a four-year period from July 1, 2018 to June 30, 2022. It includes wage increases of 4% as follows:

July 1, 2018	1.0%
July 1, 2019	0.5%
July 1, 2020	0.5%
July 1, 2021	2.0%

The following highlights other achievements:

- Implementation of a job evaluation system
- A wage agreement within the City's fiscal constraints
- Improved service delivery to residents and business community through:
  - The opportunity for extended front counter service at City Hall
  - The addition of "casual" employee definition for snow clearing and ice control
- Streamlined payment for meal allowance
- Enhanced opportunity for career growth for employees
- Allowance for tools and replacement of same
- Changes to clothing issue and footwear allowances
- Other language clean up

There is a lift station on Emberley Place that is being replaced; bringing sanitary sewer to the next manhole in the through lane on Smallwood Drive into Commonwealth Avenue.
