Deputy Mayor Locke provided an update on information (i.e. sessions on innovative graffiti treatments, urban lighting, urban forest management plan, asphalt and safety) he obtained at the above noted conference.

18-09-642 Construction Zones

Discussion ensued on the ongoing street upgrading projects, in particular Commonwealth Avenue and Roosevelt Avenue. Safety is Council's top priority and motorists were reminded to follow signage and drive slowly. Base asphalt will be placed by the end of November on Commonwealth Avenue. The frustrations being experienced by motorists and business owners were acknowledged. It was noted that if left turns were permitted in the construction zone, this would result in a backlog of traffic into the intersections. An upcoming meeting with the consultant to discuss the project was noted and a further update will be provided at the next public council meeting. Construction on Roosevelt Avenue will continue during September. To accommodate the opening of Morris Academy, everything is being done to ensure a safe environment for everyone.

18-09-643 Condolences – McKenna

Members of Council extended condolences to Sean McKenna, and his family, on the passing of his mother, Margaret.

18-09-644 Mount Pearl Blazers Under 18

Councillor Ledwell extended congratulations to the Mount Pearl Blazers Under 18 Baseball Team who won silver at the recent Atlantic Baseball Tournament held in Corner Brook.

18-09-645 Association for the Arts in Mount Pearl (AAMP)

Councillor Fry extended congratulations to member of the Association on their Arts in the Park series, noting the excellent quality of entertainment as well as their efforts in putting off the events.

18-09-651 Nighttime Construction – Street Upgrading

Councillor Power raised the issue of nighttime construction and in response, Director Antle advised the following points were considered—detours into residential neighbourhoods; noise regulations currently wouldn't permit; potentially a 30% increase in costs; and safety concerns. As a result, it was determined to proceed during daylight hours.
