19-06-443 <u>Contract Recommendation</u> Asphalt Crack Sealing TP19013 (CPR18017)

RESOLVED THAT approval be granted to award the contract for the 2019 asphalt crack sealing project to the lowest qualified bidder, Crown Contracting Inc., for the bid amount of \$33,810.00 (HST included).

19-06-445 Schedule Change Recommendation

Street Upgrading CP1 - Glendale Avenue and Bradley Place (CPR18005)

Motion – Deputy Mayor Locke/Councillor Fry

RESOLVED THAT the following schedule change for the Street Upgrading CP1 - Glendale Avenue and Bradley Place Reconstruction Project (CPR18005) be approved:

- 1. Zone 5 (Bradley Place) must be completed by October 31, 2019.
- 2. Zones 1 4 (Glendale Avenue) to be completed by October 31, 2020.

<u>Discussion</u>: It was noted that the project has been divided into five zones to ensure the entire work area does not get disturbed simultaneously. The intent of the October 31 deadline is to prevent construction to continue into late fall and winter. Allowing a two-season construction period to complete the work will provide the contractor with some security of work continuance into 2020 and is expected to lower the construction price. It is anticipated that work will start within a month. Properties requiring lateral repairs will also be addressed during the construction period.

An update on public works operations was presented. Director Antle was advised that City fencing on Roland Drive is needing repairs. Councillor Stoyles advised of complaints she received regarding line painting during the night in residential neighbourhoods (noise disturbance). PLANNING AND DEVELOPMENT COMMITTEE

19-06-455 Notice of Motion

Animal Control Regulations

Councillor Antle gave notice in accordance with Section 39 of the City of Mount Pearl Act, RSNL 1990, C-16, and Council's public notification policy, that he would, at a regular meeting of Council, move an amendment to the text of the Animal Control Regulations.

The purpose of the amendment is to provide Council with the authority to regulate the keeping of cats and dogs, domestic pets (other than cats and dogs), and to regulate livestock within the City.

19-06-456 <u>Development Permit List</u>

NEW BUSINESS

19-06-458 Mount Pearl Senior High School Prom

Deputy Mayor Locke advised that the MPSH prom will be held on Thursday, June 27, at the Glacier. He extended congratulations to all the graduates.

19-06-459 Reminder to Drivers

Deputy Mayor Locke and Councillor Stoyles reminded drivers to be extra cautious during the summer months as child pedestrians will be more prevalent.

19-06-460 Roundabouts - Costco Opening

Deputy Mayor Locke commented on the anticipated increase in traffic resulting from the opening of Costco. He questioned the road design as it enters the Galway development and whether two lanes were necessary going into Mount Pearl. The Mayor advised that the RNC will have officers in place working traffic control and our Municipal Enforcement Officers will be monitoring the Ruth Avenue/Old Placentia Road area.

19-06-461 Cameron Kinsella – 807 Mount Pearl Air Cadets

Councillor Fry extended congratulations to WO1 Cameron Kinsella who placed first in the 2019 National Effective Speaking Competition, Air Cadet League of Canada.

19-06-462 Sport Alliance Year End Barbeque

Councillor Power extended congratulations to members of the Sport Alliance on a successful year. She also acknowledged the recipients of the "awesomeness" awards – Dan Maher, Pat Cochrane, and Blair Patrick.

19-06-463 Run for Women

Councillor Power advised she participated in the recently held Run for Women fundraiser for local mental health services (Stella's Circle).

19-06-464 Pet Safe Keeping Initiative

Councillor Power advised that the City signed a Memorandum of Understanding with the Iris Kirby House, the St. John's Society for the Prevention of Cruelty to Animals (SPCA), and the Royal Newfoundland Constabulary (RNC) to work together on a Pet Safekeeping Program. The program will provide immediate support and assistance to the pet(s) belonging to victims of intimate partner violence who are leaving an abusive situation.

19-06-465 T'Railway

Councillor Antle commented on the improvements to the T'Railway by the Grand Concourse Authority in partnership with the City. He has observed some damage caused by dirt bikes and encouraged users of the trails to report such incidents.

19-06-466 Community Gardens

Councillor Antle advised that there are three remaining plots in the garden at the Gloria Pearson Community Centre. If interested, please contact the City for further information.

19-06-467 Recreation Master Plan – Open Houses

Councillor Antle advised that the Recreation Master Plan is important and although attendance was low at the open houses, there were many online and paper surveys received which will play an important role in the plan.

19-06-468 <u>Local Hero Award – MP Seamus O'Regan</u>

Councillor Ledwell extended congratulations to Patricia Janes, Barbara Predham, Carl and Jackie Goulding, and Jim Greenland who were presented local hero awards by MP O'Regan based on their volunteer experience and contributions to the community.

19-06-469 Mount Pearl Anthem Video

Councillor Ledwell acknowledged Target Marketing and thanked them for their partnership. He also expressed appreciation to staff on the initiative.

19-06-470 Best in Mount Pearl Awards

Councillor Stoyles spoke of the Best in Mount Pearl Awards ceremony being held on July 18th. She noted that many nominations were received.

19-06-471 Canada Post – Community Mailboxes

Councillor Stoyles spoke of the meeting held with Canada Post officials regarding the mailbox sites (snow clearing damages, location of some). She advised that she had emailed one of the officials identifying specific problem areas and was disappointed she had not yet received a response.
