82352 Newfoundland and Labrador Inc. (formerly Marine Dreams Inc.)
185 Commonwealth Avenue

RESOLVED THAT approval be granted to ratify the Cease and Desist Order issued to the property owner and business operator of 82352 Newfoundland and Labrador Inc., located 185 Commonwealth Avenue, pursuant to Section 109 of the Urban and Rural Planning Act, 2000.

<u>Discussion:</u> It was noted that the business was operating (involving hazardous materials) without a permit and appropriate safety requirements in place, and this constituted a serious safety hazard. This is contrary to the *City of Mount Pearl Act*, RSNL 1990, C-16, *Urban and Rural Planning Act*, 2000, the Mount Pearl Development Regulations 2010, the Mount Pearl Building Regulations 2011, and the Occupancy and Maintenance Regulations.
