19-09-607 MNL Resolution

Banning Use of Studded Tires

Motion - Councillor Ledwell/Councillor Power

RESOLVED THAT approval be granted to submit the following resolution for consideration at the MNL upcoming convention:

Banning Use of Studded Tires

Whereas studded tires are a contributing factor to premature deterioration of asphalt and concrete road surfaces, and

Whereas the wheel ruts in asphalt surfaces are caused in part as a result of studded tires, and such rutting leads to a pronounced increase in potential for hydroplaning and resulting risk of collisions, and,

Whereas more effective means of improving winter tire performance through such means as alternative rubber compounds with equal skid and brake resistance, and

Whereas infrastructure repairs, maintenance and replacement are the major capital expenditure for municipalities and the premature deterioration requires earlier maintenance.

Therefore, be it resolved that Municipalities Newfoundland and Labrador lobby the Provincial Department of Service Newfoundland and Labrador to ban the use of studded tires within the province.

<u>Discussion:</u> It was indicated that there is evidence (sand and debris following the winter season) that studded tires cause significant pavement damage. The resolution will be submitted to the MNL Board for consideration and if approved, presented at the Resolutions Session of the annual convention. If the resolution passes, it is then referred to the Province by MNL.
