19-10-721 <u>MAX Athletics</u>

Councillor Antle advised that City staff worked with MAX Athletics helping them find a space to house the 200 children in their after-school program who were displaced by the fire. Sixty-five of their children are now using the Gloria Pearson Community Centre until a long-term solution can be found. Councillor Stoyles also extended her appreciation to staff.

19-10-722 <u>ICE Awards</u>

Councillor Antle advised that the City's marketing agency, Target, has been nominated for eight ICE Awards (awards held to celebrate creativity and ingenuity for marketing agencies in Atlantic Canada) for the "Consider it Done" campaign.

19-10-723 Afternoon Tea (Seniors Independence Group)

Councillor Antle advised that he brought greetings at the recent Afternoon Tea, noting the success of the group as well as the number of community leaders who were in attendance. Councillor Stoyles also commented on the many programs offered by the Group.

19-10-724 Mount Pearl Community Supper (Wednesday - Park Place Community Centre)

Councillor Antle advised that this week's supper will be hosted by the Solid Rock Wesleyan Church, 5:30 – 7:30 pm, all were welcome.

19-10-725 O'Neill Auto Group - Foundation Pouring Ceremony for O'Neill Nissan

Councillor Antle spoke of the above event and relayed the owner's positive comments regarding City staff's handling of the development process.

19-10-726 Knights of Columbus
