Council was advised that the City has been accepted as one of 25 municipalities across Canada to participate in the Global Covenant of Mayors Showcase Studies Program (GCoM). Information on the program was presented. It was acknowledged

that many of the preliminary initiatives related to the climate change plan are associated with Infrastructure and Public Works.

Motion - Councillor Antle/Councillor Power

RESOLVED THAT approval be granted for the City to become a GCoM signatory AND FURTHER THAT the Acting Director of Corporate Services (or designate) and the Director of Infrastructure and Public Works (or designate) attend the mandatory staff workshop on January 8 – 10, 2020 in Montreal. The cost of one member to attend is covered by the program; the total cost of \$2,000 is within budget.

NEW BUSINESS

19-11-802 Remembrance Day Ceremony

Members of Council spoke on the Remembrance Day Ceremony, noting the many residents, particularly the young people, who gathered at the cenotaph at St. David's Park to honour the sacrifice of veterans.

Councillor Stoyles advised that the street sign for Richard Nolan Drive had been removed to allow for repairs after which it will be reinstalled. An update will be provided to Mrs. Nolan, the mother of W.O. Richard Nolan, for whom the street is named.

19-11-803 Community Food Drive

Councillor Stoyles advised that the Annual MPMHA Food Drive, in support of the three Mount Pearl food banks, will take place on Saturday, November 23, 2019.

19-11-804 Condolences

Councillor Stoyles and Deputy Mayor Locke recognized the passing of Preston Payne and extended condolences to the Payne and Head families.

19-11-805 Pumpkin Parade

Councillor Stoyles expressed safety concerns regarding the fire performances given the high winds the night of the Pumpkin Parade. She advised that she had also been contacted by members of the public with similar concerns. She noted that although protocol had been followed, there was a public perception of an unsafe environment.

Deputy Mayor Locke advised that safety was always a priority and the performers had been consulted to ensure they were comfortable in proceeding. He noted that the equipment used kerosene that would extinguish in the wind (there was no danger of embers).

Councillor Fry extended appreciation to the Community Event Coordinator, Rosie Stead, for organizing the event.

19-11-806 The Livable Cities Forum: Building Better Communities through Resilience

Deputy Mayor Locke highlighted some of the topics discussed at The Livable Cities Forum, an event held to discuss ways to build better, stronger and more connected communities that are prepared for the impacts of climate change.

19-11-807 <u>Hackathon</u>

Councillor Fry extended congratulations to the City's Marketing, Communications and Economic Development team for hosting a very successful Hackathon.

19-11-808 Mental Health Task Force

Councillor Fry advised that the first meeting of the Mental Health Task Force (formed as a result of an MNL resolution in 2018) was held on November 5. Members include elected officials and staff who will help coordinate the development and expansion of mental health supports in municipalities.

19-11-809 Metrobus Driver

Councillor Fry extended appreciation to a Metrobus driver, Mount Pearl resident Joshua Ellis, who performed an act of kindness for an elderly woman by tying her shoe on the Avalon Mall parking lot back in May. She asked that a letter of recognition be forwarded from the Mayor's office.

19-11-810 Sport Alliance – Chase the Ace

Councillor Fry advised that Chase the Ace is still ongoing and encouraged members of the public to support the fundraiser.

19-11-811 Lions Club Santa Claus Parade

Councillor Fry advised that the Parade will be held on December 7 and entries are still being accepted.

19-11-812 Hackathon

Councillor Power spoke on the Hackathon and extended congratulations to Acting Director Pittman and her team on such a successful event.

19-11-813 Women's Leadership Summit (MNL)

Councillor Power spoke on the Women's Leadership Summit which will kick off the Annual MNL Convention.

19-11-814 Pancreatic Cancer Awareness Month

In recognition of Pancreatic Cancer Awareness Month, Councillor Power spoke of the journey of comedian, Steve Coombs, who was diagnosed with the disease about four years ago.

19-11-815 Community Supper – Wednesday – 5:30 – 7:30 pm – Park Place

Councillor Antle advised that the weekly community supper is well attended and proving to be very successful.
