BUSINESS ARISING

20-03-145 <u>Canada Post – Community Mailboxes</u>

Councillor Stoyles advised that, in her opinion, the letter written under the Mayor's signature was unsatisfactory as it did not adequately describe the problems surrounding community mailboxes. She referenced previous meetings with Canada Post officials wherein Council was assured that the problems would be addressed. These problems include snow being pushed onto private property, damages to private property, snow being dumped in open space areas, access to trails blocked, and the use of sand for ice control. She reiterated her position that Council should have refused the implementation of community mailboxes.

Councillor Ledwell suggested that it may be beneficial for the City to meet with Canada Post officials as well as their snow clearing contractor.

Mayor Aker noted that Councillor Stoyles is welcome to draft a more strongly, worded message for Council's consideration. He proposed that the issue be referred to the Infrastructure and Public Works Committee for further consideration. He further noted that it is unlikely that the community mailboxes will be removed.

Councillor Antle suggested that a joint approach with other municipalities and Canada Post may be helpful.

Councillor Fry advised that snow should be removed from the entrances to trails and the use of sand for ice control should be discontinued.
