Councillor Antle advised that a fire advisory is in effect, however, contained fires such as firepits and chimineas are permitted in the City (no change). He noted that the fire ban issued by the Province also includes personal fireworks.

Councillor Antle advised of a meeting of the NEAJC with Eastern Health scheduled for May 6.

Councillor Antle provided an update of a recent meeting of the Library Board, noting that the library may not be opening until school resumes.

## 20-05-084 Spring Maintenance/Clean Up

Deputy Mayor Locke noted that clean-up operations are ongoing by the Public Works Department. He encouraged residents to take pride in their community by not littering and being responsible pet owners.

## 20-05-085 COVID-19

Deputy Mayor Locke reminded citizens to continue to be vigilant by taking the necessary precautions to prevent the transmission of the virus.

Councillor Stoyles extended condolences to the family and friends of Kevin Simmons, Albert Clarke and Edward Hogan.

## 20-05-087 Kinette Club

Councillor Stoyles extended appreciation to the Kinette Club on their Hearts for Hope Campaign fundraiser.

#### 20-05-088 Private Sewer Repairs

Councillor Stoyles advised that she did not support the suspension of private sewer repairs.

#### 20-05-089 <u>Smallwood Drive – Newfoundland Power</u>

Councillor Stoyles outlined her frustration with the communication and process with respect to the Newfoundland Power project on Smallwood Drive (related to the replacement of the existing power poles and streetlights with new, and more, taller poles, and power distribution from the front yards rather than currently in rear yards).
