RESOLVED THAT Change Order #3 – Addition of Reflective 3M Dots to Old Placentia Road, for the area between Nelder Drive and Richard Nolan Drive, be approved in the amount of \$16,000.00 (including HST).

20-10-389 Proposed Amendments to City of Mount Pearl Snow Clearing Regulations Authority for Regulation of Clearing of Snow from Private Property

Motion – Councillor Stoyles/Deputy Mayor Locke

RESOLVED THAT the proposed amendments to the City of Mount Pearl Snow Clearing Regulations (as presented) be approved with staff to take appropriate actions for implementation, including notification to the Minister of the Department of Environment, Climate Change and Municipalities, and the public via publishing of a Notice in The Pearl and the Newfoundland and Labrador Gazette.

It was noted that the following language will also be incorporated in the presented Regulations:

Parking Ban

- 3. During the period from the first day of December in each year to the thirty-first of March in the succeeding year, both days inclusive, no person shall park an unattended vehicle upon any highway within the City, or City owned land, between the hours of 1:00 AM and 8:00 AM.
- 4. No person shall park an unattended vehicle upon any highway or City owned land at any time during any weather event which requires City equipment to operate; and for 12 hours following the cessation of such an event.

The purpose of this amendment is to provide Council with the authority to regulate the clearing of snow from private property in order to increase safety on City streets during winter conditions, and to prevent damage to properties from inappropriate snow storage.

It was suggested that consideration be given to a communication campaign to ensure the public is aware of these changes.

20-10-390 Recommended Change Order (RCO#1) –
2020 Asphalt Crack Sealing – TP20-010 – CPR20006

RESOLVED THAT Change Order (RCO #1) for additional units of crack sealing work for the additional amount of \$10,108.00 (HST included) be approved, for a total contract cost of \$93,000.00 (HST included).

NEW BUSINESS

20-10-397 Rotary Firefighter of the Year Award

Councillor Fry advised that a group of firefighters were recognized for responding to the situation that unfolded following an avalanche in the Outer Battery during "Snowmageddon", January 2020, which sent snow crashing into a home. The group was honoured by the Rotary Club of St. John's with the 2020 Firefighter of the Year Award. Congratulations were extended to Fire Captain Barry Burke, Firefighter Sean McCarthy, Firefighter Patrick Morgan and Firefighter Cory Reid for their extraordinary efforts. Deputy Mayor Locke noted that the firefighters had extended appreciation to the snowplow operators of St. John's and Mount Pearl for their efforts in getting them to the site.

20-10-398 Northeast Avalon Joint Council (NEAJC) – Virtual Meeting

Councillor Fry advised that representatives from Pipe Down NL attended the recent NEAJC meeting. Pipe Down NL, a coalition of community groups and concerned citizens, have successfully brought the issue of loud vehicle noise to the attention of the Province and the RNC. It was understood that the Province and the RNC have pledged through a combination of regulatory changes and additional enforcement and fines to address this problem.

20-10-399 Federation of Canadian Municipalities (FCM) – AGM

Councillor Fry advised that she attended the FCM virtual AGM; she acknowledged President Garth Frizzell and Past President Bill Karsten.

20-10-400 <u>International Economic Development Council (IEDC) Awards</u>

Councillor Fry advised that the City has been recognized with 5 Excellence in Economic Development Awards from the IEDC; information on these awards was

presented. Congratulations were extended to the City's Economic Development and Marketing Team.

20-10-401 Best in Mount Pearl Awards

Councillor Fry provided information on Small Business Week and the ongoing contest, deadline October 23.

20-10-403 Girl Guide Cookies

Councillor Fry advised that the 17th Mount Pearl Pathfinder Unit are selling Girl Guide cookies online and encouraged residents to place an order.

20-10-404 FCM Board of Directors

Members of Council extended congratulations to Councillor Fry, as well as Deputy Mayor Trina Appleby (Torbay), on their election to the FCM Board of Directors. They join MNL President Mayor Sheila Fitzgerald, who already holds a seat on the Board.

20-10-405 <u>International Economic Development Council (IEDC) Awards</u>

20-10-409 <u>Nutrition App Propsre</u>

Deputy Mayor Locke extended congratulations to co-founders Colin Hunt and Jonathan Young, co-founders of the nutrition app Propsre, which won the Startup Summer Showdown (a prize package consisting of cash and in-kind services valued at over \$50,000). The contest, an initiative of Propel, the leading online accelerator, provides a new startup venture with services and some cash to start working on their idea.

20-10-410 Best Wishes – Carole Gillingham

Council extended best wishes to Ms. Gillingham, Manager of Engineering Services, who has resigned to take a new position elsewhere.
