20-10-353 Change Order – CO#14 – Glendale Avenue and Bradley Place Upgrading Project

CPR18005 – Vigilant Management (Project Management) with Dexter Construction

Driveway and Retaining Wall at 47 Glendale Avenue

Motion – Councillor Stoyles/Councillor Fry

RESOLVED THAT Change Order – CO#14 to the contract, CPR18005 – Glendale Avenue and Bradley Place Upgrading Project, with Vigilant Management (Project Manager) – Dexter Construction, be approved for a retaining wall and repaving at 47 Glendale Avenue, in the amount of \$17,793.45 (including HST).

20-10-354 <u>Contract Recommendation – One 4x4 Parks Tractor – TP20-034</u>

<u>Motion</u> – Councillor Stoyles/Councillor Fry

RESOLVED THAT approval be granted to award the contract for the supply and delivery of one 4x4 Parks Tractor, TP20-034, to the lowest qualified bidder, Atlantic Trailer & Equipment Ltd., for the bid amount of \$45,844.75 (HST included).

20-10-355 <u>Pedestrian Underpass Remediation – Old Placentia Road</u> Condition of Other Underpasses at Richard Nolan Drive and Smallwood Drive

Motion - Councillor Stoyles/Councillor Fry

RESOLVED THAT approval be granted to proceed with the concrete infill rehabilitation (option 3 of consultant's report) project, for the detailed design and construction phase in the 2020 season, at a cost of \$390,847.26 (including HST) for the pedestrian underpass on Old Placentia Road. In terms of budget, it is noted that, in addition to the funds transfer that is currently being processed for this project, a further \$80,573.86 (including HST) transfer is required among the existing multiyear capital works funding.

With respect to the other two underpasses, on Richard Nolan Drive and Smallwood Drive, the consultant advised that these are sound at this time, and estimates that any repairs or upgrading may not be required for 5-10 years; however, inspections would be required every two years to ensure any aging or deterioration does not require more immediate action.

Question called. Motion carried unanimously.

20-10-356 Proposed Amendments to City of Mount Pearl Snow Clearing Regulations Revised Notice of Motion

The Notice of Motion presented at the September 8, 2020 public council meeting was amended to include a further clause to clarify penalties of non-compliance with the Regulations. The revised Notice of Motion including the amendments proposed at the September 8th meeting as well as the additional clause clarifying penalities reads as follows:

- (a) Under Section 2, "Definitions", add: ""Contracted Snow clearer" means any individual, partnership or corporation who has been engaged by another entity to move, remove, or clear accumulated snowfall for compensation."
- (b) Under Section 8,
 - after "person", add ", or Contracted Snow clearer,"; and
 - delete "carriage way or sidewalk" and replace with "street, sidewalk, or Cityowned land, including Open Space".

Section 8 would then read: "No person, or Contracted Snow clearer, shall shovel, plow, or blow any snow from a driveway or parking lot onto a highway, street, sidewalk, or City-owned land, including Open Space, within the municipal boundaries of the City;

- (c) Add new Section 9, and renumber subsequent sections accordingly: "Where winter conditions result in reduction of traffic sight lines, snow shall not be stored in a way that unreasonably blocks sight-lines or otherwise creates a hazard.";
- (d) Under renumbered Section 10, previously Section 9,
 - after "person" add ", or Contracted Snow clearer,";
 - at end of sub-clause (a); delete "OR," and at the end of sub-clause (b), delete "." and replace with "; and/or"; and
 - add new sub-clause (c), to read "shall be liable for the cost of snow removal and/or remediation of resulting damages.".
- (e) Throughout the Regulations, make any secondary/grammatical edits required to effectively incorporate the changes described under items 1 through 4 above.
- (f) Throughout the Regulations, make any other correction/formatting required edits that may be identified, i.e. typos, and which do not alter any intent of the current Regulations.

The purpose of this amendment is to provide Council with the authority to regulate the clearing of snow from private property in order to increase safety on City streets during winter conditions, and to prevent damage to properties from inappropriate snow storage.

20-10-357 <u>Public Safety in Construction Zones</u>

The public was reminded to observe construction zone reduced speeds, follow directions of flag persons, and use extra caution and attention to safety when slowly proceeding through these work sites.
