20-11-417 Order Issued – For Ratification Overhead Door (NFLD) Ltd. | 99 Clyde Avenue

RESOLVED THAT approval be granted to ratify the Stop Work Order issued to Overhead Door (NFLD) Ltd., located at 99 Clyde Avenue, pursuant to Section 109 of the Urban and Rural Planning Act, 2000.
