Discussion

Council noted one of the unique challenges during COVID has been with supply chains for products and services. Council discussed the possibility of retendering; however, it was noted that the cost would likely be the same if not more and delivery time could be significantly longer. Council was advised that the cost of maintenance would increase if timelines were delayed due to the current vehicles being beyond service life. Council was further advised that other municipalities and organizations are experiencing similar issues and challenges and similar issues are anticipated with other tenders. Council directed that these issues should be accounted for in future tendering processes and noted that pricing stabilization should occur and should assist.

22-01-011 Current Service Offering in response to COVID, and provincial Alert Level 4

Infrastructure and Public Works will maintain core services including water testing, snow clearing and ice control, garbage collection (as per the regular schedule, including recycling), essential-only water and sewer operations, street maintenance, including pothole marking, severe pothole repair, traffic signal maintenance, animal control, and fleet repair.

Public Works Division operating as required. 24/7 supervisory presence onsite is Maintained to monitor for winter maintenance. Engineering Division and Facilities Maintenance Division are working remotely ensuring inspections, maintenance and oversight are carried out.

22-01-012 Public Works - Status Updates

Councillor Fry provided an update on snow clearing and ice control efforts noting the installation of outdoor rinks was complete. A call for assistance in maintaining the outdoor rinks was made to residents.

22-01-012 <u>Capital Projects – Status Updates</u>

Councillor Fry provided an update on City Hall Roof and Air Handling Unit upgrades with external work being completed and internal work underway.

Discussion

Council discussed possible cost savings with salt or snow clearing given the lower snowfall amounts so far this season. The IPW Director noted that it was very early in the season and while snow fall amounts have been less, the ice generated by the weather conditions could reflect an increase in the use of salt for ice control.

22-01-015 Payment Register and Purchase Card Report

Discussion

Council requested additional description and information to be provided in the report to better understand the types of payments listed. The CSED Director noted that as the report is consolidated from multiple systems this may not be possible. Council referred the matter back to CSEDC to research the request.

NEW BUSINESS

22-01-018 Outdoor Skating Rinks

Public feedback has been overwhelmingly positive on the rinks and residents have reached out to Council members expressing interest in wanting to develop and maintain a rink in their own neighborhood. Council acknowledged the work of the staff and volunteers.

22-01-019 City Walking Trails

Council noted that some residents have inquired regarding snow clearing and salting of the City's trailways. Council discussed the increases in cost and impact on service level needed as well as the possible negative environmental impact of salting the trailways. Options were offered to residents, such as St. David's Park as well as tacks for boots that provide a level of comfort when walking the City's trails in winter conditions and residents were encouraged to practice personal safety.

22-01-020 Frosty Festival

Council members noted, given the current Alert Level, the prudent decision of the Frosty Festival Board to postpone this year's festival. Residents were encouraged to enjoy their own outdoor activities and it was noted that some activities may be able to take place in the months to come with the help of the outstanding volunteer community within the City.

22-01-021 COVID Response

Council acknowledged staff, essential workers, and teams for quickly and efficiently implementing the City's response to the current Alert level. Council commended Directors and staff under the leadership of the CAO for moving the City toward safer delivery of services and noted that 2022 did not start the way anyone would have wanted. The City has effectively returned to a work from home program with full services continuing to be offered and front counter services remaining open to the public for invoice or tax payments and inquiries. Council noted that to reduce the risk of transmission, residents are encouraged to use alternative methods of payment and communication.

Council reminded residents that the provincial proof of vaccine mandate is still in place

22-01-022 Online Water Meter Readings

Council advised that commercial property owners and managers can now submit water meter readings online via the City's website.

22-01-023 Public Skating Resumed – Glacier Arena

Council noted that public skating has resumed at the Glacier Arena with a requirement to pre-book sessions and a limitation of 20 people per booking. Masks are mandatory. More information can be obtained on the City's website.

22-01-024 COVID Booster Clinic - Reid Centre

Council thanked the City staff and Eastern Health for their work and collaboration in putting the clinic in place allowing residents and the public to receive their booster shots.

Council was advised that Eastern Health Director, Stephen Lockyer passed along congratulations to the City of Mount Pearl and staff for their efforts with the booster clinic noting staff were phenomenal to work with.

22-01-025 Community Supper

Council reminded residents that the weekly Community Supper would resume Wednesday January 12, 2022 between 5-6:30 pm, serving free hot meals from the Church of the Good Shepard on Richard Nolan Drive every second Wednesday. Council noted that individuals can pick up suppers for other individuals who may be in isolation or observing public health guidelines.

22-01-026 Accessible Fitness Equipment – Functional Trainer Hoist

Council noted that new accessible fitness equipment is in place at the Summit Centre cardio room to provide people with a wide range of weight training and exercise options.

22-21-027 <u>2022 Tax Notices</u>

Council noted for the information of residents that the 2022 Tax Notices have been sent out.

22-01-028 Winter Parking Ban

Council reminded residents of the winter parking ban, which is currently in effect from December 1st to March 31st, both days inclusive, between the hours of 1:00am and 8:00am. Council noted that the ban helps Public Works to complete snow clearing and ice control on the City's streets.

22-01-029 Recreational Facility Changes during Alert Level 4

Council advised the public of the following changes to help ensure public safety:

- Swimming lessons suspended and refunds will be issued for registration fees.
- Bubble swims (to a maximum of 6 people per bubble) and parent and tot swims can be booked via the online booking system. Lane swims are drop-in, first come-first served.
- Recreational facilities are operating at 25 per cent capacity as per Public Health guidelines, including but not limited to the Summit Centre fitness room.
- Youth drop-in center programing at the Reid Centre is suspended.
- Public bubble skating is now available at the Glacier Arena.

The information and booking options for services at the City's facilities is available on the City's website.

22-01-030 Canadian Ball Hockey

Council congratulated Jack Chafe and Logan Smith on their selection for the U16 Boys Junior Team Canada for the 2022 ISBHF World Ball Hockey Championship.

Congratulations were also extended to Kieran Burke who was selected for the U20 Boys Junior Team Canada for the 2022 ISBHF World Ball Hockey Championship.

22-01-031 Welcome Home Maggie

Council celebrated the return of Maggie. After 9 days lost, Maggie was found and returned home to be reunited with her family.

22-01-032 Emily Hepditch

Council congratulated Mount Pearl author, Emily Hepditch, on signing a publishing deal with Flanker Press to publish three additional books.

22-01-033 Christmas Community Supper

Council noted that the Christmas Community Supper was held on December 15, 2021 at the Church of the Good Sheppard. Thanks was given to Scott Hillier of Coffee Matters for his efforts and contributions.

22-01-034 Northeast Avalon Joint Committee - Meeting with Eastern Health.

The Committee met with Eastern Health for a check in to discuss issues from a municipal perspective. Eastern Health noted 8,000 boosters were being administered per day with a goal of 12,000 per day. Council advised residents to be patient noting 200 Eastern Health staff members have been re-deployed to administer the boosters and they are rolling out as quickly as possible.
