#### 23-07-349 Best in Mount Pearl Awards

Councillor Fry thanked all those who nominated anyone for the Best in Mount Pearl Awards and acknowledged that the effort to do was special and appreciated.

# 23-07-350 Canada Day and Memorial Celebration

Councillor Locke thanked city staff and the City's Events Coordinator for organizing the celebrations at St. David's Park and noted there was lots of positive feedback from residents who attended. He also noted the Memorial Celebration and the wreaths laid at the cenotaph.

Councillor Antle also offered thanks to the Director of Recreation & Community Safety and team for their organization of the celebrations on Canada Day.

#### 23-07-351 <u>Trailway Crosswalk – Commonwealth/Park/Ruth Avenue</u>

Council members spoke of safety concerns with crossing at the designated crosswalk at the Commonwealth/Park/Ruth Avenue intersection. The item was requested be brought to the PED Committee again to review a safe option similar to other municipalities.

Councillor Locke noted safety concerns already reviewed regarding the placement of a crosswalk at the trailway entrance and stated that while he would not support placement at the trailway that would put the public at risk, he would support a review of the current crosswalk with regard to improving safety. He also noted that future plans for improvements to the bridge in this area would include a pedestrian underpass which would address safety issues.

Councillor Rice wanted to acknowledge and thank Sherry Fitzpatrick and others for organizing events/contests/games during Public Service Week. He acknowledged and thanked staff for the organization and work on the Hall of Fame Banquet, assistance with the Tely 10 and organization of the Canada Day Celebrations.

He asked that more contact be made with Legion, Branch 36 to promote events such as the wreath laying for Beaumont Hamel at the Cenotaph on Canada Day.
