### 24-03-113 <u>Funding Announcement – Government of Canada's Housing Accelerator Fund – Helping Build</u> <u>More Homes, Faster in Mount Pearl</u>

Councillor Lane spoke to the funding agreement between the Federal government and the City. She provided highlights and information on how the funding would be used to help reach the City's goal of accelerating the process of developing additional housing units in the City.

Council members spoke to the funding the City has received and acknowledged the crucial need for housing. They also acknowledged the interest the announcement has generated, and the contacts Council members have received from developers and residents. They noted the funding was provided, not to construct housing, but to accelerate the process and planning that will lead to the development. Council members noted the City is reaching out to residents regarding the Municipal Plan Review and asking for their input as the plan will dictate how the City moves forward with a focus on intensification. WH	EREAS,	Purple Day is a global effort to promote Epilepsy Awareness in countries around the world; and
WHI	EREAS,	Purple Day was founded by nine-year-old Cassidy Megan of Nova Scotia, who wanted to let people know that if you have epilepsy you are not alone; and
WH	EREAS,	Epilepsy is a chronic neurological disorder, which affects each person differently, estimated to affect more than 10,000 people in Newfoundland and Labrador, over 300,000 people in Canada, and 50 million people worldwide; and
WH	EREAS,	One in ten persons will have at least one seizure during their lifetime; and
WH	EREAS,	The public is often unable to recognize common seizure types, and unable to respond with appropriate first aid; and
WH	EREAS,	Purple Day will be celebrated on March 26th annually to increase understanding, reduce stigma, and improve the quality of life for people living with epilepsy throughout the country and globally

The following status report is provided for information:

#### Roads

- Winter shift continues for the 2023-2024 season.
- The primary focus is on snow clearing and ice control as work continues with snow removal from City streets, sidewalks, cul-de-sacs, fire hydrants, islands, etc.


