25-03-115 Public Works Status Report

A status update for Public Works was provided for information. Winter shift schedules are ongoing, work continues on the outdoor rinks, and snow removal and clean up continues as required under the Roads Division. Councillor Rice reported that snow in cul-de-sacs has been pushed back and completed. Trail maintenance and grooming are ongoing in the Parks Division. Service and maintenance continue in the Fleet Division and winter equipment maintenance is ongoing. Information was provided on UTM general calls, snow removal around fire hydrants and low point catch basins as required, and water and sewer repairs are ongoing. Water levels at Bay Bulls Big Pond as of February 24, 2025 were attached for information.
