## 16-04-239 Contract – St. David's Park Re-Development MA9695

RESOLVED THAT approval be granted to award the Reid Centre Interior Renovations contract to the lowest qualified bidder, J&T Construction Limited, for the bid amount of \$1,287,424.01 (HST included).

<u>Discussion:</u> A summary of the interior renovations was presented. It was confirmed that chair samples are being considered by Community Services staff for the Seniors Independence events. It was noted that the facility will close during renovations and re-open in September for the fall programs.

Question called. Motion carried unanimously.

#### 16-04-241 Bay Bulls Big Pond – Water Levels

The most recent report of the water level at Bay Bulls Big Pond was presented. Residents were reminded that a conservation order is in effect year round and to be mindful of water consumption.

With respect to the Water Conservation Order, it was clarified that hand watering of lawns with a watering can or hose with an automatic shutoff nozzle was permitted at any time. It was suggested that the ban on the washing of parking lots also include residential driveways. It was requested that the IPW Committee review the various conditions of the Order in conjunction with the Regional Water Committee.

# 16-04-242 Project Update

It was noted that the Gymnastics Facility is approximately 95% complete with an anticipated completion date of May 2016. Council commented on their recent tour of the facility noting that Campia Gymnastics will be taking over the facility this summer. # 16-04-243 Karwood Contracting

Extension of Development Permit - 33-39 Municipal Avenue

RESOLVED THAT approval be granted to extend, for a period of one year, the development permit issued for a proposed seniors development at 33-39 Municipal Avenue subject to the previous terms and conditions.

<u>Discussion</u>: Council commented on the length of time it's taking this project to commence construction and expressed concern with extending the development permit for another year given the number of seniors waiting for housing. It was noted that the circumstances of the appeal filed against the project attributed to some of the delay. It was indicated that the developer has advised that the project is to commence in June. It was suggested that the extension be granted to August 31, 2016.

Motion to Amend Original Motion: Councillor Aker/Councillor Stoyles

RESOLVED THAT approval be granted to extend the development permit to August 31, 2016.

<u>Discussion:</u> Councillor Ledwell was not in favour of reducing the one year extension given the importance of the development and in recognition of the current financial situation. It was suggested that a meeting be held with the developer advising of Council's desire to having the project proceed on a timely basis and to completion.

Question called on amended motion. Motion carried with Councillor Ledwell voting against the motion.

Question called on original motion as amended. Motion carried unanimously.

Councillor Aker presented a point of clarification noting that in the past he has declared a potential conflict of interest because he is employed by the Newfoundland & Labrador Housing Corporation (NLHC), however, the Appeal Board determined that he wasn't in conflict because NLHC is a nonprofit organization.

#### 16-04-251 <u>Masonic Park Nursing Home</u>

Members of Council expressed their disappointment with the recent announcement that Masonic Park Nursing Home would be closing. Mayor Simms advised of discussions held today's date with Eastern Health, David Diamond, who provided information about the rationale to close the facility. It was agreed that a letter would be written to the Minister of Health outlining Council's position (copy to be provided to members of council for review prior to being released).

#### 16-04-252 Winter Maintenance – Public Works

Councillor Tessier advised that night shifts have finished, however, in light of the pending storm; the day shift staff will be extended to cover snowclearing operations. Residents were reminded that the Snowclearing Regulations stipulate that parking on the street is not permitted during a storm or 12 hours thereafter.
