# 16-04-203 Contract - Street Markings TP16-008

RESOLVED THAT approval be granted to award the street markings contract to the lowest, qualified bidder, Clearaway Contracting Ltd., for the bid amount of \$514,921.23 (HST included).

<u>Discussion:</u> A question was raised as to whether the bid was competitive as only one bid was received. It was noted that there are not many companies that offer this service but this bid was comparable to last year's. It is planned to investigate the cost of private sector versus undertaking the work in-house. It was indicated that the thermoplastic applications in centre lines showed less deterioration and will continue in selected areas.

# 16-04-204 <u>Contract - Landscape Maintenance Tender TP16-010</u>

RESOLVED THAT approval be granted to award the landscape maintenance contract to the lowest, qualified bidder, Murray's Landscape Services, for the bid amount of \$93,319.92 (HST included).

#### 16-04-205 Contract – Smallwood Field House (Arena) Demolition TP-15-021

# 16-04-208 <u>Acquisition of Crown Paving Property</u> Pearlyiew Open Space Area

RESOLVED THAT approval be granted to purchase the property identified as 1016D Topsail Road within the Pearlview Open Space area for the amount of \$30,000 plus the costs associated with the survey and legal work to transfer the property to the City.

<u>Discussion:</u> Council was advised that this is the last piece of land to be acquired and the process for park plan preparation will commence via an RFP process that will include consultation with the public.

# 16-04-209 Revocation of Airgun Bylaw & Amendment to Noise Regulations

Motion - Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT the Air Gun Bylaw adopted on the 8<sup>th</sup> day of August 2, 1994 be revoked AND FURTHER THAT the City of Mount Pearl Noise Regulations 2015 be amended as follows:

In Section 2 Interpretations, add

"Airgun" means a gun commonly referred to as B.B. or pellet gun and all guns operated by pump or spring mechanisms and compressed gas cylinders regardless of muzzle velocity.

"Firearm" means a device such as a handgun, rifle, shotgun or any other similar device, used or capable of being used to fire a projectile from a cartridge or shot shell;

In Section 3, General Prohibitions add the following after the first paragraph.

(b) No person shall create a noise within the City through the use of fire arms, airguns or similar noise-making devices, except as approved by Council and subject to the approval of law enforcement and other regulatory agencies.

#### 16-04-210 Public Meeting Protocol

RESOLVED THAT the public meeting protocol be adopted as presented AND FURTHER THAT this protocol be posted on the City website, available at public meetings and that presenters at public meetings be advised of the protocol.

# 16-04-211 65608 Newfoundland and Labrador Inc. (CarTunes) New Building (Second Building on Lot) 1196-1200 Topsail Road

Motion - Councillor Walsh/Deputy Mayor Locke

RESOLVED THAT the development application by 65608 Newfoundland and Labrador Inc. to develop a second building on the lot and associated site work at 1196-1200 Topsail Road for a proposed combined Light-Industrial (Warehouse) and Commercial Garage Use be approved and a development permit issued subject to the following conditions:

- 1. Newfoundland Power's conditions
- 2. Bell Aliant's conditions
- 3. St. John's Regional Fire Department's conditions
- 4. Engineering Services Division's conditions
- 5. Inspection Services Division's conditions
- 6. Planning and Development Department's conditions
- 7. A detailed Landscape Plan, a completed Landscape Cost Estimate Form and a minimum \$4500.00 refundable Landscaping Security fee to be submitted for review and approval by the City prior to any building permits being issued
- 8. The retention of the natural vegetation, trees and shrubs adjacent to Thomas Byrne Drive shall be maintained
- 9. A revised detailed Site Plan illustrating the following shall be submitted for review:
  - a. Site plan shall be stamped by a Professional Engineer licensed to practice in the Province of Newfoundland and Labrador
  - No portion of the proposed building (including footings or eaves) can protrude into the NL Power easement area, all portions of the new proposed building to be removed from easement area
  - c. Rock pits (soak away areas as per the site plan) are not permitted, all storm water drainage must be connected to the City's storm sewer system, rock pits to be removed from site plan
  - d. Correct western property boundary (property boundary is shown as west edge of access easement area on current plan submitted)
  - e. Access easement area (please hatch on plan)
  - f. The reconfigured parking spaces at the rear of the parking lot shall be illustrated so that all the parking spaces are on the subject parcel and there is a minimum landscaped area at the property boundary
  - g. All paved parking areas to be curbed
  - h. If washrooms or sprinkler system are required, servicing laterals to be illustrated on site plan, including type, size and grades of inverts
  - i. The information on the existing services laterals is missing, illustrate type and size of inverts and also what the size of the catch basin leads are
  - if a street excavation is required, street cut and details of street cut to be illustrated on site plan
- 10. Engineering consultant to submit a pre-post storm water calculation to indicate if existing catch basins can maintain site storm water
- 11. A Development Agreement for "Two Buildings on One Lot" is required to be signed

- 12. The exterior facade (siding) of the second building on the lot shall match or be complimentary to the exterior facade (siding) of the existing principal building on the lot
- 13. The development meeting the Mount Pearl Development Regulations 2010

#### 16-04-212 Variance Request to Maximum Floor Area

Proposed Accessory Building

24 Hillhurst Street

RESOLVED THAT a 10% variance request to increase the maximum accessory building area standard at 24 Hillhurst Street to 29.32 m² to accommodate the accessory building be approved and a development permit be issued subject to the proposal meeting the conditions of the Development Regulations and Building Regulations.

#### 16-04-215 Notice of Motion

<u>Amendment – Mount Pearl Development Regulations</u>

Deputy Mayor Locke gave notice that in accordance with Section 39 of the City of Mount Pearl Act, 1988 and in accordance with Council's public notification policy, he would, at a regular meeting of Council move an amendment to the text of the Mount Pearl Development Regulations 2010 that, if enacted, will:

- 1. In Section 2 Definitions, add the definition for "Community Garden"
- 2. In Section 7 Special Developments, add a section titled "Community Gardens" that outlines the conditions which apply to the use;
- 3. In Section 11 Use Zone Schedules, add "community garden" as a permitted use in Residential, CON, PB and OS use zones.

The purpose of this amendment is to define community garden use, outline the conditions for the use and identify the use as a permitted use within a number of use zones.

#### **NEW BUSINESS**

## 16-04-216 <u>Mount Pearl Senior High – Environmental Club</u>

Deputy Mayor Locke extended congratulations to the Club on their success in being one of three schools selected to ask David Suzuki two questions on environmental rights. The Club participated in the Blue Dot Movement's Campus Challenge where they competed against other schools and universities in Canada for the most pledges to conserve water.

# 16-04-217 <u>Congratulations – Mayor Simms</u>

Members of council extended congratulations to Mayor Simms on the birth of his grandson.

#### 16-04-218 Mount Pearl Paradise Skating Club

Councillor Stoyles extended congratulations to the Club on a successful year end show.

#### 16-04-219 Condolences

Councillor Stoyles extended condolences to the family and friends of Brent Cole. Mr. Cole's contributions as Deputy Mayor of Whitbourne and Chair of SOPAC were acknowledged.

#### 16-04-220 Amendments – Anti-Litter Regulations & Development Regulations

Councillor Walsh advised that the proposed changes to these regulations requiring garbage containers at commercial properties have been acknowledged by some business owners. He was pleased to see the uptake and encouraged the public to forward ideas or input addressing the litter problem to the Planning & Development Department staff.

# 16-04-221 Snow Clearing Regulations

Councillor Walsh reminded residents that although the overnight on-street parking ban was lifted, parking is not permitted during a storm or 12 hours thereafter.

## 16-04-222 Mount Pearl Paradise Skating Club

Councillor Aker also extended congratulations to the Club and commented on the value of having Nam Nguyen (2015 Canadian Champion) in attendance.

#### 16-04-223 Citizen of the Year

Councillor Aker advised that the Kinsmen Club Citizen of the Year will be held on April 8 at the Reid Community Centre. Congratulations were extended to nominees Bill Vincent, Sandra Milmore, Donna Collens, Sandy Woolfrey-Fahey and Emma Thornhill.

# 16-04-224 Gymnastics Facility

Councillor Aker noted that a tour of the gymnastics facility had been arranged for members of council. He reminded attendees to wear safety gear as it is a construction site.

#### 16-04-225 Demolition – Smallwood Arena

Councillor Aker advised that the contractor has 90 calendar days to remove the Smallwood Arena following the contract award.

#### 16-04-226 Waterford River Watershed Management Plan - RFP

Mayors Simms advised of a meeting with the Mayors of St. John's and Paradise regarding the Waterford River Watershed Management Plan RFP. He noted that all three municipalities are very supportive of this initiative and focused on the health of the River. The second phase of this project would be how to make the River a regional asset.

#### 16-04-227 Anti-Litter

Mayor Simms reiterated the importance of working with the community to abolish the problem of litter. It was confirmed that the amendment process includes a public consultation component. Council was informed that officials with the utility companies support working with the City to address the issue of graffiti and a meeting will soon be held to discuss the matter.
