#### 16-05-340 Public Works Maintenance Updates

Maintenance updates were provided on roads, fleet, parks and UTM.

It was noted that lawn repairs are underway, i.e. areas are being prepared for the laying of sods. (Sods are not available yet from the City's source.)

With respect to private sewer repairs, it was indicated that a list has been compiled and a plan is in place to carry out the repairs. It was noted that prior to starting the sewer line repairs, some leak repair work had to be completed as an earlier commitment was made.
